Personal information we collect

The personal information that we collect about you through the App depends on how you interact with us:

- *Information that you provide voluntarily*

The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. Some of this information may be collected using cookies and similar tracking technologies. Data security
