Playground Project

- First grant application was sent off this week! To Kal Tire RePlay for recycled rubber surfacing. Potentially received \$15-\$20K in funds. Actual cost to install rubber surfacing is approximately \$120,000.
- Rubber surfacing statistics for the mini playground:
 - 5,200 square feet / 480m2
 - Will require 76,000 pounds / 34,500 kg of rubber surfacing.
 - Works out to be 2,200 recycled tires.
- We have received a first draft of our business plan from KJ Street Consulting. This will accompany large grant applications.
- Currently reviewing possible grants to apply for with Q1 application deadlines.
- We have received letters of support from our Community Association and City Councillor, and we are expecting to receive a letter of support from our MLA and possibly our MP. Letters of support are used to help enhance our chances of obtaining grants.
- Discussion: Core playground rope status and pea gravel cleanup event.
 - Images shown of the three rope structures affected in the Core playground (Beehive, Apollo and Red Planar)

Status of the Core playground rope structures:




- 1 "Red Planar" popular for the "floor is lava games".
- 2 "Beehive" older grades play on the higher levels, with smaller students playing on the lower levels.
- 3 "Apollo" all children play on this moving piece of equipment

Structures 1&3 can be replaced at any time for \$8995 + GST. Structure 2 does not have a current design. Anticipated in 2 years.

Examples of the "Beehive" rope fraying exposing the cable.







- Q from Amber Harlal:
 - Can the rope replacement be covered by Casino funds?
 - A: Yes, but all available Casino funds remaining from 2023 Casino proceeds and a large portion of the 2025 Casino proceeds are being directed towards the Mini playground replacement in 2026.
- Q from Ashli Johnson:
 - Will the metal equipment need replacing in 5-7 years if we replace the rope now (cost of \$10-20K)?
 - A: CBE says the structure is deemed fine and may last longer than 7 years.
- Q from Michelle Atkins:
 - Can we just replace the rope and not replace the rope structures when the Core playground gets replaced? (replacing all structures except the rope structures)
 - A: Possible but any changes 5 years later to the rope structures would affect the integrity and warranty of the proposed pour-in-place rubber surfacing. Another reason

is that metal fatigue will be that much greater over time. Unpredictable how that will fare. Assessment would be crucial at time.
