Dear members,

As you are aware the number of "EAGLE Act " cosponsors is rising day by day! Thus, it is imperative that we respond quickly, inform our representatives about it, and **meet** them.

Therefore, we are asking you to write to the House representative of your congressional district to explain the bill and ask for a meeting. Depending on whether your House member is a Republican or a Democrat, we have prepared two different templates for you.
