## Purpose of Ordination & Ministry Licensing:

<u>Ordination</u> and <u>Ministerial Licensing</u> serve distinct purposes within the local church, though both fulfill similar functions with the IRS.

<u>Ordination</u> is reserved for biblically qualified elders who feel called to a lifetime of vocational ministry as a pastor. Its purpose is to confirm this pastoral calling, preparing the individual for a lifelong commitment to ministry. It also allows the church body to affirm and anoint the pastor for ministry. This act of laying on hands and offering affirmation and prayers reflects a practice seen throughout the New Testament, symbolizing the anointing and power that only God can bestow for effective pastoral service.

Ministry Licensing is a significant and honorable recognition of an individual's calling to serve in a vocational ministry role within the church. This licensing affirms the heart, character, and commitment of those dedicated to ministry, confirming the church's belief in their ability to effectively serve and minister in various capacities. Through ministry licensing, the church formally acknowledges God's calling and gifting to these individuals, supporting them in their ministry journey and empowering them to serve in a meaningful and impactful way. Like ordination, ministry licensing carries the weight of responsibility and is given only to those who have demonstrated maturity, a commitment to the faith, and alignment with the church's values and mission. Sometimes, an individual is licensed for a season and then later ordained after demonstrating additional calling, spiritual maturity, and an expanded role within their church body.

<u>Tax and Financial Benefits.</u> Both ordination and ministry licensing afford pastors and licensed ministers specific tax and financial benefits under IRS guidelines. These benefits recognize the unique nature of vocational ministry. Licensed and ordained ministers may qualify for a housing allowance, exempt from federal income tax when used for housing-related expenses. Additionally, ministers may be eligible for self-employment tax exemptions and deductions specific to their ministerial income. These provisions help support pastors and ministry leaders in their service, providing practical assistance that allows them to focus more fully on their calling.



## Requirements:

Students are required to read the books listed below and complete the following assignments by the deadlines listed during the ordination process. We will gather as a group for a brief discussion on what you're learning after each deadline. One of these homework assignments includes a theological essay. You can select from a list of topics below. We will complete the ordination process with an individual oral interview with a group of ordained pastors from our Triangle Network Churches. We've compiled a list of possible questions to help you prepare.

- \*\*\*Required book reading and Bible reading can begin before the ordination track begins so the student can space out their workload.
- \*\*\* A student may be eligible to skip related sections if they have taken a relevant Bible School or seminary class.

#### **Ordination Council Oral Evaluation**

Students pursuing ordination will also be required to sit before an ordination council to complete their ordination requirements. The applicant may be asked and should be prepared to respond orally to the following questions/requests during their ordination council oral evaluation:

# **Theological Evaluation**

- 1. Defend the doctrine of the deity of Christ.
- 2. Defend the doctrine of the Trinity.
- 3. What does the Bible teach regarding the salvation of man?
- 4. Describe the purpose of baptism
  - What is its purpose?
  - Is it for all believers?
- 5. Describe the gifts of the Holy Spirit and how you see them functioning today.
- 6. What do you believe regarding the second coming of Christ?
- 7. Describe the Scriptural teaching on tithing.
- 8. How did you personally come into a faith relationship with Jesus Christ?
- 9. What do you believe the Scripture teaches about homosexuality?
- 10. What is your philosophy of the role of church eldership?

#### **Practical Evaluation**

- 1. When and how did you sense God calling you into pastoral ministry?
- 2. What area of ministry do you feel called to?



- 3. What areas of ministry have you served in?
  - o Currently serving in?
- 4. What results have you seen in past ministry experiences?
- 5. Have other leaders/mature believers confirmed your call to ministry? If so, how?

## Relationship to Your Local Church:
