

# **Privacy Policy for Magic Speech AI Chrome Extension**

## **Introduction**

This Privacy Policy explains how this extension collects, uses, and discloses your information. By using this extension, you agree to the terms of this Privacy Policy.

## **Information Collected**

This extension collects the following information:

- Audio recordings: The extension records your voice input when you activate speech-to-text functionality. These recordings are temporarily stored locally on your device and are not sent to any servers.
- Transcribed text: The extension transcribes your audio recordings into text. This text is used solely within the extension to insert text into web pages or applications. It is not stored or transmitted elsewhere.

## **Information Use**

The extension uses the collected information to provide the following features:

- Speech-to-text functionality: The extension transcribes your voice input into text, which you can then insert into web pages or applications.

## **Information Sharing**

The extension does not share your information with any third parties.

## **User Choices**

You can control the extension's access to your microphone by adjusting your browser's permissions settings.

## **Data Retention**

Audio recordings are deleted immediately after they are transcribed. Transcribed text is not stored permanently.

## **Security**

The extension takes reasonable measures to protect your information from unauthorized access, use, or disclosure. However, no security measures are perfect, and the extension cannot guarantee the absolute security of your information.

## **Additional Notes**

- The extension does not collect any personal information about you, such as your name, email address, or IP address.
- The extension does not track your browsing activity or use cookies.
- You can disable the extension at any time by uninstalling it from your Chrome browser.

## **Explanation for Various Permissions required for the extension:**

**"activeTab"**: This permission allows the extension to access the currently active tab in the user's browser. The extension needs this permission to inject the button into the webpage and interact with the content of the active tab, such as inserting text into input fields or contenteditable elements.

**"scripting"**: This permission is necessary for the extension to execute the provided script within the context of the web page. The scripting API is used to inject scripts to add mic button into web pages. The script interacts with the page by adding a button, listening to events, and manipulating the DOM, which requires the scripting permission.

**"microphone" (implicitly required)**: The code uses the Web Speech API (`webkitSpeechRecognition`) for speech-to-text functionality, which requires access to the user's

microphone. While the microphone permission is not explicitly declared in the manifest, the browser will prompt the user for microphone access when the extension attempts to start speech recognition.

**"<all\_urls>":** This is a broad permission that allows the extension to access and interact with all websites. Given the nature of the extension, where it could be useful across any website with text input capabilities (such as email clients, forums, social media, etc.), this permission would be necessary. It allows the content scripts to be injected into any web page that the user visits, enabling the speech-to-text functionality universally.
