The Near East Foundation (NEF) has long been committed to supporting locally led development and to strengthening local institutions related to resource governance, livelihoods, and peace. We will use the LLA principles to challenge ourselves to (1) do more through our programming and operations to empower local counterparts and to fully engage local communities in program strategy, design, implementation, and monitoring; (2) to advocate for programs, policies, and funding streams that are consistent with the LLA principles; and (3) to hold ourselves accountable across the full spectrum covered by the 8 principles.

1. Devolved decision-making	NEF currently supports local decision-making through its organizational structure – in which local staff lead on programming strategy and technical decisions – and through our programs, which include, e.g., decentralized climate finance for public goods investments and community-based revolving funds that support entrepreneurship. We commit to (1) prioritizing scaling these programs to increase local access to finance; (2) investing in and prioritizing local partnerships, local decision-making, and locally led actions in these and other programs; and (3) strengthening capacities of local staff, partners, and institutions.
2. Addressing structural inequalities	NEF is committed to building economic, social, and climate resilience among vulnerable and marginalized groups, prioritizing women and youth, smallholder farmers, people with disabilities, and conflict-affected people, displaced persons and their host communities. NEF will continue to direct its programming towards mitigating structural inequalities that limit these groups' voices in decision-making and knowledge sharing, their access to economic opportunity, and their access to and control over natural resources.

3. Governance and	NEF supports the long-term development of local governance processes, capacity, and
predictable	institutions for direct access to climate finance. This includes through capacity-building,
funding	natural resources governance institutions, and decentralized climate funds that enable
	communities to prioritize and implement adaptation actions. NEF will continue to promote
	these modalities where there is local support for them and will advocate for these
	mechanisms with international communities of practice. NEF similarly will seek to scale
	locally controlled revolving funds that support adaptation and resilience in the private
	sector, including in conflict-affected communities.
4. Investing in local	NEF invests in local institutions that can continue and evolve resilience programming,
capabilities to	including local governance institutions, economic associations and services, locally
leave an	controlled revolving funds, and civil society. NEF will work consistently with such
institutional legacy	institutions to identify and promote systems, revenue streams, and policies that ensure
	their longevity and effectiveness.
5. Building a	NEF has made an organizational commitment to mainstream and integrate climate risk

6. Flexible	NEF's programming will engage local stakeholders (institutions, partners, individuals) in
programming and	program strategies, design, monitoring and evaluation and will engage them to lead in
learning	evidence-based adaptive management strategies that ensure programming is tailored to
	local needs, supports locally led decision-making and implementation, and results in
	sustainable outcomes and institutions that increase resilience
7. Ensuring	NEF regularly engages local stakeholders in steering committees and engages local
transparency and	stakeholders on needs assessments, market assessments, and resilience assessments. We
accountability	will expand these practices, ensure they are inclusive and offer meaningful participation to
,	a full range of stakeholders, will support capacity building for local counterparts on
	monitoring and evaluation, and will share evidence with local stakeholders to ensure our
	programs are more transparent and accountable.
8. Collaborative	NEF's work focuses on individuals with multi-faceted vulnerabilities; it therefore operates
action and	at the nexus of sustainable development, climate action, humanitarian assistance, and
investment:	peacebuilding and stabilization. NEF will continue to work across sectors and advocate for
	multi-sectoral solutions that are grounded in locally led action and actors and we will work
	with local counterparts to encourage multi-sectoral approaches that break down silos,
	address root causes, and result in mutually reinforcing resilience solutions.
