



2022 NIAA 3A and 1A State Basketball Championships

The 2022 Nevada Interscholastic Activities Association Class 3A and Class 1A State boys and girls basketball championship tournaments are scheduled to be played February 24-26 at Cox Pavilion and (for the 1A) Chaparral High School in Las Vegas.

TOURNAMENT FORMAT

Both Class 3A tournaments will be four-team, single-elimination tournaments. The top two finishers in the Northern and Southern Region tournaments will advance to the state tournament.

Both Class 1A tournaments will be eight-team, single-elimination tournaments. The top two finishers from the Central, East, Southern and West League tournaments will advance to the state tournament.

Cox Pavilion is adjacent to the Thomas & Mack Center on the northeast corner of East Tropicana Avenue and South University Center Drive. Parking is available in the designated lots near the Thomas & Mack and Cox Pavilion. Parking in other areas around the arena is subject to ticketing/towing.

Chaparral High School is located at 3850 Annie Oakley Drive in Las Vegas. The phone number to the school is 702-799-7580. Athletic administrator Steven Bentz and athletic director Matt Balodis will serve as site directors.

HOME TEAM

In all postseason basketball brackets, the higher seed will be the home team and will wear light jerseys. If teams are equally seeded, the top team on the bracket will be the home team.

GENERAL INFORMATION

This tournament and all games within it will be governed by the National Federation basketball rules book, the NIAA Handbook, the NIAA reference manual, the Basketball Postseason Tournament Information and General Policies packet and this tournament information packet. All decisions based on information included in the aforementioned materials are final. This packet is a binding document for the tournament it serves.
2. The site director will assign locker rooms and bench locations. The site director will have the final say on all game-related manners.
3. Tickets will be sold through HomeTown Ticketing, the NIAA's official partner for postseason ticket sales. Tickets are available both through the ticket page on the NIAA website (niaa.com/tickets/index) and the HomeTown Ticketing app.

Admission prices for NIAA postseason region and state events (per event) are:

Adults: \$12

Students with a valid high school or younger ID: \$5

Children age 8 and younger are admitted free.

NIAA Courtesy Cards and Lifetime Passes will be honored for the legitimate pass holder and one guest.

4. No artificial noisemakers of any kind will be permitted at NIAA contests. Balloons and/or other objects that may impair spectator vision also are NOT permitted at any contests. Tournament officials will always have the final say on what is or is not appropriate.
5. Capacity limits for games may be instituted by the site director/host school to comply with any school district, local or state policies.
