

# **EXPLANATION**

As you may have heard, ICE & HHS have lost – do not know the location of – almost 1500 children. \*UPDATE - 3000 children.

You may have also heard about the cruel way that children are literally being grabbed from their parents' arms and taken away in a new policy initiated by the President and Jeff Sessions.

We must take action to stop this inhumane treatment of people, many of whom are seeking asylum from dangerous situations that they have escaped.

# \*\*Be AWARE. 2 separate things are occurring.

First is the children who passed through the Office of Refugee Resettlement and were "lost" (UACs - Unaccompanied Alien Children) AND Second is the children who are now being forcibly removed from their parents.

The "lost" children arrived alone in the United States and were place with relatives or people with longstanding relationships. This system of placement had a lot of holes in it and the restrictions were tightened in 2014 as to where exactly the children were headed. (People need to prove their relationship with the children.) Once they are place with relatives, it is no longer the job of the ORR to track them. They do cursory follow-up calls. However, it is one school of thought that one does not want them to do more than that because often the parents of these "lost" children know where they are and simply do not want them tracked by the government, especially in the current anti-immigrant atmosphere. Especially relevant now that ORR will be turning the information on these children to ICE, which they had not done in the past. In fact, with the tightened restrictions, more children are staying in detention - some until they are 18 and then they are turned over to ICE for deportation. It is recommended, instead, that local welfare agencies (who don't liaise with ICE) follow-up to make sure these children are safe. The new - initiated by this current Administration (announced by Sessions) - policy of forcibly taking children from their parents is different. The ORR and ICE know where they are - but are not telling the parents. They are being labelled as UACs when they are taken from their parents, even though they did not actually arrive alone to the country, and ORR is placing them and ICE is tracking them. Being tracked by ICE is not something most Immigration Lawyers would recommend for their clients. So, in your communications with ICE & ORR, it is suggested that you not demand they track the "lost" children as some believe that this is a tactic by this Administration to use the demands to justify toughening release procedures so that the children are not released and the following scrutiny is used to also deport their relatives.

1. Postcard your Senator and Reps to ask them to immediately put in place protections. Their job is to conduct oversight of DHS—they must hold DHS accountable

Also ask them to support:

HR5950 Humane Enforcement and Legal Protections (HELP) for Separated Children Act

– To protect children affected by immigration enforcement actions
