REGISTRATION FEE SCHEDULE

Registration fees for the 2024-2025 school year are \$535 for the first child in each family, \$390 for the second child, and \$335 for each additional child. **All Parish and Tuition families pay registration fees.**

CHECKLIST

- ☐ Complete the "Authorization for Automatic Withdrawal for School Fees" for registration, tuition, extended care, and lunch fees if you wish to have these fees automatically paid.
- ☐ Ensure all account balances have been resolved by the completion of the current school year.
- ☐ Submit completed materials to the school.
- ☐ **Parish families must complete stewardship packets before registration is accepted.**
- ☐ **Both parents must have current Safe Environment Requirements for Parents before registration is accepted.**

Registration and paperwork is due by May 17, 2024.
