The Trumpet Could Still Blow

Not Over Yet

Many of us who went through the years following the 2020 election heard of a case, known on the docket as Case 22- 380 and was filed on October 20th of 2022. On January 10th of that year the Supreme Court decided not to hear it. But this was the first petition by Loy Brunson and he has two more attempts. What was the case alleging? Here is what it challenged by the petition as seen in an article from *amg-news*:

For those unfamiliar, the Brunson Case is a legal challenge with the potential to shake the very foundations of American politics. The Brunson brothers argue that the 2020 election certification violated their constitutional rights by disregarding evidence of fraud. They claim that those who certified the results, from Congress members to Vice President Pence, did so without adequate investigation, effectively undermining the people's will.

While many believe that when the case was denied that it was dead. But according to the Brunsons, that isn't true:

*One key factor that makes the Brunson Case so intriguing is Rule 11. Under Supreme Court procedures, if the Court denies a hearing, it doesn't mean the case is dead—it can still be **“pulled off the shelf.”** This little-known rule has fueled hopes that the Brunson Case, even if previously dismissed, can resurface at any time. Imagine the surprise, the shockwaves, if this case reappears without warning and becomes the vehicle for what Trump supporters believe will be justice.*

*Rule 11 is especially powerful because it allows the Supreme Court to take up a case of **“exceptional importance”** at any time, even if it was initially denied. This gives the case a sense of ticking urgency. In a world where timing is everything, Rule 11 could be the key to unlocking what Trump supporters see as the nation's salvation. To them, this case could be the ultimate Trump card, a surprise that nobody saw coming but everyone has been waiting for.*

Yes, I know that I and those who are seeing this as another shot at making things right will be seen with the usual conspiracy theorists filter. However, this could happen.

They Already Ruled

As the article goes on, they state that a ruling was already handed down but was kept secret: *Supporters believe that the Supreme Court has already heard this case behind closed doors. If this secret hearing did indeed happen, as some allege, then Trump's “little secret” could change everything. Imagine a scenario where a Supreme Court ruling declares the 2020 election invalid. The repercussions would be unprecedented. The Military has not released the verdict of the Supreme Court yet to prevent CIVIL UNREST It really did happen. Trump will officially be put back into office BEFORE January 20th.*

And How Do Things Change?

To some it will really escalate the great exposures we've been praying for. It would justify how we've felt all along about the 2020 elections and maybe going back further. And it would clean a lot of the swamp out in one fell swoop. The posts above make statements that don't make sense like Justice Thomas is in favor of the case, which doesn't mean much more than one vote. Is A Storm Coming?

Yes, I'm full of good news now, aren't I? I keep hearing prophetic words on a storm coming for America. I found a [video](#) that deals with this notion and here is what it tells us:

God is sending Messengers with warning dreams—Watchmen, prophets, and intercessors—to warn us and show us things to come. I wonder how many more dreams God needs to give His people before we'll begin to take these warnings seriously. The latest comes from Annette Capps, the daughter of the late Charles Capps, a pioneer in Christianity in his day. Annette had a vivid dream about something we need to prepare for, and she's issued a critical prophetic warning for the body of Christ.

The author of the video is *Jennifer LeClaire* and she goes on to tell us this:

She is not alone. We are seeing more and more warning dreams from leaders and believers in the body of Christ. This is a manifestation of Joel 2:28. Joel prophesied—and Peter later repeated this prophecy—saying, “And it shall come to pass afterward that I will pour out my spirit on all flesh; your sons and daughters shall prophesy, your old men shall dream dreams, your young men shall see visions.”

She then played a clip from *Annette Capps*:

I want you to listen closely to this soundbite from Capps' dream and reflect on whether God is speaking to you about similar things. Listen carefully, as you will:

"We are in a very peculiar, particular era of time for sure, one that has a sense of urgency in the spirit. A few days before September 9th, I had a dream one night. In this dream, the Spirit of God... I thought it was a normal dream. You ever have those where you think it's just normal? So, in my dream, I'm asleep, and while I'm asleep, I'm dreaming. I didn't even know this was possible. But anyway, I kept fidgeting and fighting because I could hear a phone ringing—it was ringing and ringing and ringing. Finally, in my dream, I woke up and realized the phone had been ringing, so I got up to answer it.

Well, when I woke up from the waking up in the dream, I woke up in reality and heard the phone ring. I jumped up and grabbed my phone, and then I realized it was all a dream. Wow. So, I thought, okay, this was just a weird dream, right? But what happened later is that I had this sense, and I said, 'Lord, I think that dream meant something,' and He's like, 'Uh-huh.' I said, 'In my dream, I think the phone rang five times while I was asleep in my dream.' And He said, 'That's correct.' I said, 'Five could mean five days, five months, five what? Is it five something?' God instructed her to check out her journal:

Then the Spirit of God spoke to me and said, 'Go back in your journal five years—this time of the year for the past five years since 2018.' So, I went back, and each year at the same time, in the fall, at the beginning of the fall year, I had written that the Spirit of God was impressing me that there's something coming that we need to prepare for. And so, you know, in your own mind, you think, well, maybe it's this, maybe it's that, or whatever. I didn't know what it was, but I felt it so strongly that I did something odd.

Capps then felt like she and her staff needed to prepare for the storm and then she decided to I started telling my staff, 'I don't know what it is, but I feel like you need to get some water, extra food, and keep your car filled up with gas.' I said, 'I don't know what it is that's happening, but I just feel this pretty strongly.' So, anyway, I went through each of those years, and I didn't realize that over that five-year period, each year it happened.

Eventually the dream really ended:

This year, I started feeling it, praying about it, and then I woke up in my dream, I woke up, and then I really woke up. The Spirit of God said, 'I want you to share it.' Because I've had things over the past five years God told me, and it's like, 'Don't say anything, just keep it.' But this time, He said, 'Share it.'

A Similar Experience

LeClaire had a similar experience in September of this year.

On September 9th, I got up, and I said, 'You know, I may be marked with the crazy people. I may be marked from here on out—oh, did you hear what Annette Capps is doing?' But it was so strong in my spirit. What God said is to let people know to get prepared. Don't get scared. Don't get scared. God's always let His people know when something's coming so they can get ready." Annette gave people some ideas of how to prepare. She said, "The thing most on my mind is water—get some extra water, figure out how you can have water if something happens. I don't know what it is; don't ask me. I'm just saying this." She talked about food—canned food. She mentioned keeping your car filled up with gas, keeping cash on hand, and being aware that if you don't have electricity, you won't have water. She emphasized the interconnectedness of it all. She said she believes the dream give to Capps was real:

This is a time to heed these warnings. Although Annette doesn't have as many details as she'd like, she couldn't shake the dream. That's a sign—a true, sure sign—when God won't let you forget it, when it keeps stirring, and you keep meditating on it. That's often a dream from the Lord. Many others are experiencing similar revelations.

Leclaire then mentioned a similar dream before the 2020 lockdowns:

God showed me a similar dream before COVID. He showed me that the food supply would be hindered. We've seen that to some degree, but I believe we'll see it to a greater degree. Many others are saying the same. God is revealing what the enemy plans to do—perhaps something with the electric grid, the water supply, the food supply, or all of the above.

He admonition for now is the same one I have for us:

This is not the time to fear; it's the time to build up your faith. Get into the Word of God, pray in the Spirit, and fellowship with the Lord. Equip yourself in the natural and in the Spirit to endure these end times.

Beloved, we are in the end times. The whole world is in crisis, and the signs of the times are accelerating. We're in a hinge moment in history. The enemy knows his time is short.

Amen. Let us work during the day because the night is coming when no one can work.
