- The purpose of this group is to support performance management at large.

- Dave Vautin created and shared the scorecard. Good efforts in collaboration space. Communication has been a focus this year, a more regular process. The area needing additional focus is research – have brought on William Johnson as the research coordinator.

- The committee has two topics this year featured during the meeting.
  - Equity performance measures Session on Monday, great presentations.
  - Resilience performance measures Monday PM session, moderated by Jay Styles from Virginia DOT. Good panelists and questions.
- Coming Up Soon:
  - Looking back over the first four years of TPM. This is the topic of an upcoming TRB Webinar in March. Thanks to those who helped coordinate. DV There will be normal TRB communication and want to leverage the informal connections. Was interested by TR News, going to write an article about it perhaps May or June newsletter.
- Michael Grant shared a need for session coordinators. Let him know if you are interested.

### **Communications Updates.**

- Lori Richter shared an update on behalf of the Communications Task Force. This
  team supports meetings, notes, periodic emails, and periodic e-newsletters. The
  Task Force is working to get members connected with TRB and the tools they are
  making available. Announcements and notifications can be shared, so let us
  know if you have any information you would like to communicate to members
  and friends.
- Newsletter distributed on a bi-monthly basis. The next deadline for content is mid-February, going out at the end of February.
- Demo of website. Using Google sites to develop the page. Photos will scroll, link to Dave Putz's email for the mailing list, committee purpose, news on TRB, pictures of committee leadership, and task force contact info. Christina Leach will be sending out a request for images of leadership.

#### Federal & AASHTO Updates.

- Mshadoni Smith-Jackson, FHWA Team Leader for the Performance and Asset Management Team provided an update. She thanked all state DOTs for completing the PMF process. With the end of first full performance period, FHWA Division Offices are due to be done processing information by Friday, February 13, 2023. They are also reviewing their communication processes.
- Other FHWA updates
  - Bipartisan Infrastructure Law (BIL) There are several infrastructure aspects. FHWA is working on how best to accommodate mandates.
  - Transportation Asset Management Plan (TAMP) recertifications were completed by end of 2022.
  - The TRB Asset Management Conference will take place July 8-11, 20023 in Boston, MA.
  - The FHWA resource center is looking at the division office call for support.
     FTA recently adopted 5 strategic initiatives in the first strategic plan in 20 years.
  - Question: Greenhouse Gas (GHG) performance measures (PMs) –
    anything to share? Nothing to share, received thousands of questions,
    still working through responses. Equity and safety measures addressing
    mandates out of the bill to incorporate those aspects.
- Matt Hardy provided an update on behalf of AASHTO.
  - Partnerships on research. To be successful, AASHTO and TRB need to work together, especially in the area of research.
  - The research symposium was started remotely (during COVID) and continued over the past two years. We would like to do this again to maintain partnership/collaboration. We were successful in getting a number of research projects funded. For example, the Asset Risk and Resilience Manual. Got funded for \$4 million, 2nd largest ever. Needed partnership between AASHTO and TRB to get it accomplished. How can I get involved? Are you from a state DOT? Hard if you are not from state DOT. Contact the AASHTO CPBM Task force on Emerging Performance Areas Deanna Belden if interested.
  - We invite you to attend the AASHTO TAM and TPM webinars. These are scheduled monthly on Wednesdays from 2-3:30 PM. They are recorded and archived at <a href="https://itpm-portal.com">https://itpm-portal.com</a>.
  - Conference in Providence, 3 days of intense sessions, All sessions will be posted on the TPM Portal site. There were three tracks comprising Performance Management, Planning, and Data.
  - AASHTO has a new technical service program. There are resources available to do work.
  - AASHTO supports members in addressing federal regulations. Five areas of concentration: GHG measure, safety, performance measures, HPS, and pavement definitions. Planning provisions: state-wide and metropolitan

planning aspects. TAM some important changes and new guidance (resilience & climate change), (CORNELL LAW). HSIP – IIJA created some conflict between national FHWA and NHTSA – which will need to be figured out to help state DOTs address. Suggestion AASHTO taking on steady or improving performance.

### **International Activities Update.**

- Christos Xenophontos provided an update on behalf of the International Coordinating Council (ICC). He indicated that chairs wanted to know more about how to collaborate with Council. Suggested consideration of AJE20 and peer committees and ICC for workshop/webinar.
- He presented information on Coordinating Councils (see slide deck). Research is critical. Need representation from aviation and naval areas. Climate change and de-carbonization are areas of focus.
- TRB number of memos of understanding (MOUs) with the ICC. He shared structure of ICC. (again, see slide deck). Shared vision and mission as part of a ICC TSP. GOAL 1: Collaborate with TRB technical Committees on International Activities. Encourage TRB participants to initiate and engage in international activities to increase international collaboration. GOAL 2: Engage International Colleagues and Partners in TRB Activities, Committees, and Panels. Actively engage international colleagues in TRB activities, committees, and panels. GOAL 3: Leverage International Cooperative Benefits through Convening Activities. Facilitate external collaboration with partners and TRB participation in partner events and activities.
- ICC used TRB's 12 Critical Issues to identify relevant Technical Committees to work with. Also want to invite members of Standing Committees to become friends of ICC.
- Christos provided an update on 2022 ICC developments and activities and highlights of TRB 2023 Annual Meeting ICC-sponsored events. (see slide deck).

### Research Updates & Priorities Brainstorm.

- Michael Grant provided an update on the NCHRP project Effective Methods for Setting Performance Targets. The Primary product is a guidebook, which includes methods sorted into categories. Examples of implementation are included, as is a conversation about philosophy. Ultimately, is the process of setting a target lead to good conversations about performance.
- Michael shared some AJE20 research. He recognized Matt Hardy and Edgardo Block from the Connecticut DOT.

- He reiterated that the committee needs to partner with others and learn who can help successfully compete / complete research. 23-32 Transportation Asset Risk and Resilience \$4M, 08-168: Analysis and Assessment of the National Performance Management Data \$500K. 08-169: Valuing Diversity, Equity, and Inclusion in Transportation Asset Management \$500K. 08-167: Guide Creating Effective Visualizations \$375K.
- AJE20 related Research Needs Statements Submitted FY24. (see slide deck for details). Talk to your state DOT research directors.
- Michael shared the timeline of important dates. (see slide deck).
- AJE20 Research Coordinator William Johnson from Colorado DOT provided update.
- He conducted an AJE20 Research Needs exercise. Q: What are your research needs for performance management monitoring and adjustment? Q: What are your research needs for performance-based planning and programming? Q: What are your research needs for performance reporting and communication? Q: What are your research needs related to resource allocation for performance management? Q: What are your research needs related to target setting? Q: What other performance management topics need to be addressed? Volunteer to develop research needs statements (Name, Or, Email).
