

I find it ironic that Katherine Chong the co-founder of Polaris Project who helped develop the US training to combat human trafficking is still promoting failed policies that have resulted in the [harassment and detainment of Kathleen Chan, Jay Serrano](#) and many other Americans. This failed approach of profiling has been around for quite a while.

[I confronted Katherine Chong](#) about Polaris Project publishing fake stats on their website in 2015 which resulted in them removing the inaccurate information. Katherine Chong stated publicly that Polaris Project does not provide any direct services to victims. They are receiving 3 to 7 million in annual federal funding, to run a 24 hour hotline and relay those tips to local law enforcement.

[Yet many others media outlets](#) keep republishing these [myths and misconceptions](#) and they purposely conflates sex trafficking with prostitution. The moral witch hunt goes on.....

Meanwhile researchers are reporting that the majority of the women in the US sex industry are consenting adults who choose to engage in sex worker and many of them are independent sex workers, and they are not victims under the control of evil pimps and traffickers. According to a [2008 John Jay College study in New York](#). Many youth **show** a surprising amount of agency and **control** over their work .

Similar results were found in the "[2014 Surviving the streets of NY: Experiences of LGBTQ Youth, YMSM & YSWW Engaged in Survival Sex](#)" where the majority of minors found engaged in survival sex reported that they didn't have pimps and that they teach each other how to find clients and avoid police and social workers. The sex trafficking hysteria has already caused [several teens to be charged with sex trafficking.](#) In [Alaska they arrest and charge sex workers](#) with trafficking themselves and for working together to ensure their safety.

Homeland security also want to [ensure that sex workers can't travel freely and stay at hotels](#) without being profiled, harassed and arrested. So [Homeland Security is asking hotel staff to report customers for having too many condoms.](#) That is right, they want hotel staff to spy on their customers. How would hotel staff know how many condoms a customer had unless they are ILLEGALLY searching the customer's personal belongings.

So why does Homeland security want to make it harder for sex workers to access condoms and stay safe? Many states use "condom for evidence laws". These laws are used so the police can arrest anyone they suspect is engaging in prostitution, without even having to prove it. Meanwhile the US recently [lifted the ban that prohibited the funding of clean needle exchange programs.](#) So while they fund health depts "free condom programs" [sex workers are at risk of arrest for just possessing condoms.](#)

I think it is high time we ask why Homeland security, DOJ + the FBI why they are refusing to implement policies that reduce violence and exploitation in the sex industry. Why are they purposely creating stigma and violence toward sex workers. Why do they keep making up [Super Bowl trafficking hysteria](#)? Their refusal to implement harm reduction policies, makes it crystal clear that the criminalization of prostitution is being enforced to punish

women who won't conform and who refuse to stop doing sex work. Since when did persecuting sex workers stop human trafficking.?

To add insult to inquiry, US law enforcement agencies are known to exaggerate and lie to the media, with claims that women are being rescued from sex trafficking. More often than not, they arrest the sex worker and prosecute her for prostitution, promoting prostitution or trafficking, if the woman refuses to say she has been forced into prostitution. This recently occurred in Seattle with the raid on a website called "The Review Board." [Maggie McNeill](#) a feminist Whore [debunks the King County sheriff's press conference:](#)

Meanwhile trafficking NGOs do not offer any REAL services to trafficking victims or sex workers. They do not offer subsidized housing or jobs that pay a living wage. Trafficking NGOs are just referral agencies and they usually only have access to the same services as everyone else who dials 211 looking for shelter, food, medical services etc. The majority of public and private shelters refuse to take in sex workers or adult victims of trafficking. Domestic violence shelters refuse to take in the wives of police officers who are victims of domestic violence because the police know the location of these shelters. Many trafficking NGOs are on local trafficking task force and these groups work with law enforcement in prostitution raids and they are given immediate access to the women and they become hostile and abusive if the women say they consented to do sex work. If the women refuse to say they were forced and are victims, they are arrested and prosecuted.

[The sex trafficking hysteria is a global scam that squanders US tax dollars](#), while promoting stigma and violence towards a vulnerable population. But why would they quit now, when staying on course will keep the money rolling in. There is no transparency or accountability and this looks like the biggest criminal enterprise I have ever seen. This is a global scam that does more harm than good. It essentially ignores human trafficking in other labor sectors, even though this is where the majority of human trafficking occurs.

In 2015 Americans saw more excessive force by the police than in previous years. While most Americans heard about the arrest and conviction of [police officer Daniel Holtzclaw](#) who raped several women. I bet they don't know how many police officers have been convicted for sexual assaulting women and children. I wonder why Homeland security thinks putting aggressive cops in charge of spying on and stalking women and teenagers who are involved in the sex industry would ever be a good idea. In August 2015 [Amnesty International passed a proposal recommending the decriminalize](#) of adult prostitution, clients and 3rd party-support staff, to ensure the human rights of sex workers.
