

Treasury Order 100-01 New Currency Engravings

SUBJECT: An order to change the back portrait on the ten-dollar note and front and back portrait on the twenty dollar note.

- 1. **SCOPE.** This Directive applies to the Director and Department of the United States Bureau of Engraving and Printing.
- 2. **DEFINITIONS.** For the purpose of this Directive:
 - a. the term "ten" shall refer to the ten-dollar note currently made by the United States Bureau of Engraving and Printing.
 - b. the term "twenty" shall refer to the twenty-dollar note currently made by the United States Bureau of Engraving and Printing.
 - c. the term "Tubman" shall refer to the American abolitionist and activist Harriet Tubman, who was born into and escaped slavery, and is credited with the creation and facilitation of the Underground Railroad.
 - d. the term "Parks" shall refer to American civil rights activist Rosa Parks, who was deemed by Congress as "the first lady of civil rights" and "the mother of the free movement", and who inspired the Montgomery Bus Boycotts.
 - e. the term "Anthony" shall refer to American activist and women's rights activist Susan B. Anthony, who led the way for women's suffrage and equal rights in the United States.
- 3. **ENFORCEMENT** IN GENERAL, by the powers vested in me as Secretary of the Treasury in 31 U.S. Code § 5112, it is hereby ordered that:
 - a. The portrait of the United States' Seventh President, Andrew Jackson, shall be removed on both the front and back portrait of the twenty-dollar note. The image of Harriet Tubman shall replace Andrew Jackson on the front portrait of the

twenty. The image of Rosa Parks shall replace Andrew Jackson on the back portrait of the twenty.

- i. The director of the U.S. Bureau of Engraving and Printing shall direct the U.S. Bureau of Engraving and Printing to replace the front portrait of the twenty with the image of Tubman in no more than five (5) years after the issuance of this order.
- ii. The director of the U.S. Bureau of Engraving and Printing shall direct the U.S. Bureau of Engraving and Printing to replace the back portrait of the twenty with the image of Parks in no more than five (5) years after the issuance of this order.
- b. The portrait of the first Secretary of the Treasury of the United States, Alexander Hamilton, shall be removed on the back portrait of the ten-dollar note. The back portrait of the ten shall be replaced with an image of Susan B. Anthony.
 - i. The director of the U.S. Bureau of Engraving and Printing shall direct the U.S. Bureau of Engraving and Printing to replace the back portrait of the ten with the image of Anthony in no more than five (5) years after the issuance of this order.
- c. All legal ten and twenty dollar notes currently in circulation, or those that will be printed before the changes as outlined in this order take effect, will remain legal tender within the borders of the United States of America.
