Contains the results of testing using the method presented in the method section.

Limitations:

This section is not a weakness of the researcher, but contains research weaknesses that were not carried out because they were beyond the control of the researcher.

Implications:

Contains follow-up on research results and research limitations. Research results can be followed up practically and academically. Limitations can be suggested for further research.

The abstract should be 150-200 words long and written in past tense. Nomenclature standards should be used, abbreviations and citations in the abstract should be avoided.

Keywords: 3 – 5 words.

1. Introduction

This chapter outlines the background adequately. The research problem should be elaborated with a short review of literature and previous related publications. Authors are required to include excerpts from articles previously published from relevant or related journals. Describe the purposes of the research to complete this part.

The manuscript must be original, has never been published before or is in the process of (in the process) other publications. The body of the manuscript (not including abstracts and bibliographies) is written in a minimum of 3000 words and a maximum of 6000 words, in A4 paper size with 1.15 spaces, Times arial font size 12. The title of each part must be bolded while the subsections are in italic form. Average left 2.5 cm, 2.5 cm right flat, 2.5 cm lower limit, and 2.5 cm upper limit.

Manuscripts written in English are only allowed with certain provisions relating to translation work. Arabic script quotations are typed in Transparent Arabic letters measuring 18 points, while the transliteration text follows the congress's standard library. Quotations are written by following the APA (American Psychological Association) standard, in this case the model used in APA is a quote in the text, for example: (Arikunto, 2006).

This chapter should contain sufficient technical information so that the method can be repeated by others. Describe conclusively that the method used is a new method and, if necessary, use a table

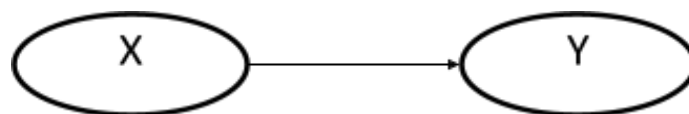


Figure 1. Framework research

3.1. Results

This chapter contains the results of the research. Results can be presented in the form of text, tables, and interpretations accompanied by reported results. The tables are accompanied by sequential numbering and should be quoted in the body text.

3.2. Discussion

The discussion can be either in a separate subsection or integrated within the results section. The author should discuss the findings from the research with relevant literature.

4. Conclusion

The conclusion must be presented based on the study findings. Writing the conclusion must be in simple and concise sentences so easily to understand by the reader. Accompanied by a new understanding/perspective/insight that refers to the research results obtained. Write down limitations and future research that can be reviewed and provide recommendations.

Acknowledgements

Acknowledgements can be delivered to the parties who have helped with the research and completion of the writing of the manuscript. These parties can act as mentors, funders, providers of data, and so forth.
