

Adopt TOS:

**I ONLY accept money/USD payment through CashApp, this is for security, and due to PayPal's habit of randomly deleting people's accounts. That, and I'd overall like to avoid managing money with minors, as has been mentioned in my [Commission TOS](#). This is primarily due to legal reasons, as doing business with a minor can get your account deleted as well.**

**Game currency or currency on forum games is at a far lower priority state than USD for me, so please do be aware that offers of that nature may be rejected in favor of USD.**

I have no issues with you reselling the design for a higher price, than bought. As long as there are other pieces involved to justify the price raise, especially a massive price extension.

**You may absolutely modify/simplify markings and marking placement, but please keep it at least a bit recognizable!**

(This means edits can be somewhat heavy!) As long as I can tell that the design has elements from the version sold to you, it is okay. If I can match the two versions up and see that they are similar, it is good.

**If you feel as though you are not at a skill level to be able to properly redraw or redesign a character that you want to purchase from me, feel free to ask me about edits before purchase, I am happy to modify the design to your needs.**

You only have to credit me for the artwork that I have done, and nothing further! (Unless you have a ToyHou.se, and want to credit me for the design. My username there is BigCatBites!)

**If you adopt a design on a base, DO NOT TRACE OVER that base and claim it as your own, or pass it off as your own work.**

**I will report you to the base maker, as soon as I possibly can, because that is theft. UNLESS you credit the base maker, and state that you've done edits.**

After purchase/trade is complete, you will be sent an unwatermarked version of the file, this is usually done via email. (This can be fully unwatermarked, or include my

signature/logo. Whichever is most comfortable for you! A completely "clean" or, no watermark at all version, is preferred to be used personally. Ultimately, I can't control what you do, **just please be mindful of theft, and that people are more than happy to steal unwatermarked files.**)

**I will never accept anything below the value of \$2 USD.**

I **do NOT** tend to do **trades** with **beginner artists**, primarily due to **bad experiences** and a repeat pattern of TOS not being fully read or understood; if not outright **ignored**. There have been exceptions, but that has been few and far between.

Do not prod at me, if I haven't answered your offer, quite yet. I may be busy, or resting. If you keep prodding me, you will be ignored. **"Prodding" means spamming**, in this case. As in multiple messages at once. **If you message me over the span of a few hours, that is understandable.** But, **please do not** send me, say, three to six messages in the span of under two minutes.

**It is preferred that you communicate to me in a paragraph format, as I do have cognitive impairment and it is rather tough for me to keep up with rapid messages in succession; and I am more likely to make mistakes on my end. Please be mindful of this!**

**Do NOT** claim the original artwork as your own! This includes if I use a base, **CREDIT THE BASE ARTIST, AS WELL, PLEASE!!**
