I. Project AWARE Update

We have now hired the clinician for this program, Anne Lear. We had previously hired the program manager (Jackie Muncy), as well as the community navigator (Samantha Vivian-Gonzales). A local evaluator will be hired by UNM to collect data on the program.

II. Narcan Training

SCOPE will be holding voluntary trainings for staff on the use of Narcan. Naloxone (Narcan) is a medication approved by the Food and Drug Administration designed to rapidly reverse opioid overdose. It is an opioid antagonist—meaning that it binds to opioid receptors and can reverse and block the effects of other opioids, such as heroin, morphine, and oxycodone. School nurses, nurse assistants, and administration are the only staff members who would use it on students, if needed, but staff members who are interested in learning about Narcan and how to administer it can attend training. Each participant will receive a resource bag that has local Socorro resources, information handouts, safe storage/disposal information, as well as a box of Narcan nasal spray. The trainings are scheduled for May 3rd and 4th after school at Parkview and Sarracino Middle School. We currently have 25 staff members signed up to attend one of the two trainings.

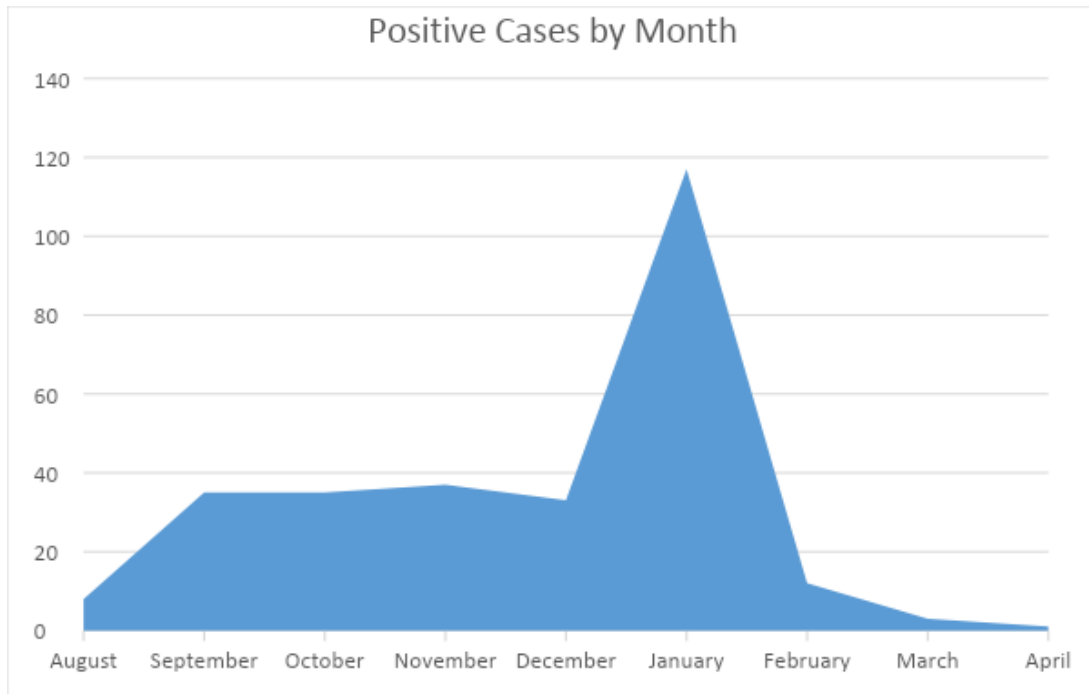
