This course is assessed in 2 different ways.

Unit 1: This unit focuses on theory and is evaluated through several written assignments. These assignments assess your understanding and application of theoretical concepts covered in the course.

Unit 2: Assessment for this unit involves uploading various types of evidence. This includes plans, assessment records, and feedback related to practical applications of the course material.

Please note that to conduct assessments for this course, you must have at least two learners enrolled in the qualifications you are assessing.

What are the Requirements for the Assessor Qualification

You should have math and English skills at a Level 2 standard. As part of the course requirements, you must arrange to assess two learners. This involves evaluating their performance and gathering evidence for your portfolio. Learners must also be observed by an **expert witness**, a qualified assessor within an organisation who will verify that their work was conducted correctly. **Moreover, candidates have 12 months to complete the course, providing enough time to engage with the material at their own pace.**

1. What is the AVRA qualification?

AVRA stands for Assessing Vocationally Related Achievement. This level 3 assessor qualification focuses on assessing competence in a learning environment. To complete this course and earn the qualification, you must assess the competence of two learners.

2. How many units are in this assessor course?

The Level 3 Award in Assessing Competence in the Work Environment comprises two units.

Understanding the Principles and Practices of Assessment (Unit 1) teaches the principles and requirements of assessment, the different assessment methods, how to plan an assessment and much more.

Assess Occupational Competence in the Work Environment (Unit 2) teaches how to plan the assessments of occupational competence and maintain legal requirements when assessing occupational competence.

3. Is an expert witness required for this Level 3 assessor course?

Yes, you do require an expert witness for this course. An expert witness is a qualified assessor within an organisation who verifies that your assessments were conducted correctly before your course tutor grades them.

4. What is the difference between Level 3 AVRA and ACWE Assessor Courses?

AVRA stands for Assessing Vocationally Related Achievement. This level 3 assessor qualification focuses on assessing competence in a **learning environment**. On the other hand, ACWE stands for [Assessing Competence in the Workplace Environment](#) and focuses on assessing occupational competence in a **professional environment**.

5. What are the entry requirements for this course?

You must have a minimum of level 2 in literacy or numeracy or equivalent and be at least 18 years old.

6. How is the Level 3 Award in Assessing Vocationally Related Achievement (AVRA) assessed?

To conduct assessments for this qualification, you are required to have access to a physical workplace. This is because the qualification is competency-based, meaning you must

demonstrate practical skills and knowledge in a real-world environment. You must have at least two learners enrolled in your assessment qualifications.

7. How do I provide assessment evidence?

Learners upload assignments and assessments on to the online portal, with 24/7 access, for tutor's feedback and marking.

8. What happens if a learner refers on an assignment?

If you refer on an assessment, your tutor will give you detailed feedback to help you understand where you need to improve. You will revise your work based on this feedback and submit an improved version.

9. Do I need access to real learners to complete this course?

To complete the Level 3 Award in Assessing Vocationally Related Achievement (RQF), you must have access to a minimum of 2 learners who are enrolled in real qualifications for assessment purposes. Please note that we do not supply learners for assessment purposes.

10. How long does it take to complete the Level 3 Award?

Generally, candidates take 2-3 months to complete the course, yet you have up to 12 months to do so, giving you plenty of time to finish. Please note that after these 12 months, additional fees will apply.
