We must pass our new constitution before 5 April 2026

Key changes to bring us in line with new Rules regarding Charities and Incorporated Societies

- Move to annual AGM (one at TE and one on Zoom)
- Move financial end of year to 31 June to align with timing of our Training Events
- The new Constitution does take out the specific description of

"5.5 Full membership will be granted to Associates on proof of the completion of 50 hours of supervised spiritual direction work."

However note this from the new constitution

9.4 The Executive has the power to edit and change documents in the Association's Policy and Operating Manual, as long as the underlying meaning of the words at questions is not changed. Other changes to Association Policy documents must be approved at a General Meeting."
