The Vernon Township High School administration reserves the right to prohibit any individuals from purchasing a Prom Bid or entrance into the prom. The VTHS student will assume full responsibility for the behavior of their guest and will leave with their guest if he/she is asked to leave. Both the VTHS student and his/her guest must comply with all of the school rules.
