## **[TEMPLATE LETTER]**

Hello,

I'm writing to demand justice for the murder of Tony McDade on Holton Street in your city on May 27, 2020.

First of all, please use Tony's correct name (Tony McDade) and pronouns (he/him) on the official police website and in any communication with the press. To use his birth name and she/her pronouns is a huge sign of disrespect and an act of violence.

I am appalled by the events that took place and the lack of transparency that has been provided. We need answers about exactly what happened, and justice for Tony and his family.

A complete and transparent public and independent investigation must take place. We demand that a special prosecutor be appointed to investigate the Tallahassee Police Department. We demand the release of all body camera footage, and the arrests and full prosecution of all officers involved. All information and evidence must be made available to the public as soon as possible.
