For uniformity in writing, especially original research manuscripts must follow the following systematics:

1. Title of the essay (Title)
2. Name and Institution of Author (Authors and Institution)
3. Abstract (Abstract)
4. Manuscript (Text), which consists of:
 - a. Introduction
 - b. Methods
 - c. Results
 - d. Discussion
 - e. Conclusion
5. Bibliography (Reference)

B. DETAILED EXPLANATION

1. Writing Titles

The title is written briefly, clearly, and concisely, which will describe the contents of the manuscript. It should not be written too long, a maximum of 20 words in Indonesian. Written in the top center with Sentence case (only has a capital letter at the beginning of the sentence), Calibri 13pt font, not underlined, not written between quotation marks, does not end with a period (.), gives a Bold effect, without abbreviations, except common abbreviations.

2. Writing the Author's Name, email, and Institution

The Calibri font size is 11pt, left aligned made according to the principle of not using titles, and is equipped with an explanation of the origin of the institution or university. Writing the author's name starts with the author who has the biggest role in creating the article. The maximum number of authors is 5 authors, for writing emails in the box to the left of the manuscript in the Corresponding Author section:

3. Abstract Writing

The abstract is a miniature of the article as the reader's main description of your article. The abstract contains all the components of the article briefly (purpose, methods, results, discussion, and conclusions) using Indonesian and English. Calibri font size 10pt Maximum length of 200 words (must not exceed these provisions), do not include bibliographic quotations and be written in one paragraph. Abstracts are written in Indonesian. Equipped with 3-6 keywords.

4. Introduction Writing

The introduction leads the reader to the main topic. The background or introduction answers why the research or study was carried out, what previous researchers did, or current scientific articles, problems, and objectives. This chapter also emphasizes the clarity of disclosure of the background of the problem, differences with previous research, and the contribution that will be made.

5. Writing Methods or Methods and Materials

Method writing contains research design, place and time, population and sample, data measurement techniques, and data analysis. It is best to use passive sentences and narrative sentences, not command sentences.

6. Writing Results

When writing results, only research results are written which contain data obtained in research or the results of field observations. This section is described without providing discussion, write it in logical sentences. Presentation of results and sharpness of analysis (can be accompanied by tables and pictures to facilitate understanding).

7. Writing the Discussion

Discussion is the most important part of the entire content of a scientific article. The purpose of the discussion is to answer the research problem or show how the research objectives were achieved and interpret/analyze the results. Emphasize new and important aspects. Discuss what is written in the results but do not repeat the results. Explain the meaning of statistics (eg $p < 0.001$, what does it mean? And discuss what significance means. Also, include a discussion of the impact of the research and its limitations.

8. Writing Conclusions

Conclusions contain answers to research questions. Conclusions must answer specific objectives. This section is written in essay form and does not contain numbers.

9. Table Writing

The table title is written in title case, the subtitle is in each column, is simple, not complicated, shows the existence of the table in the text (for example, see table 1), is made without vertical lines, and is written above the table.

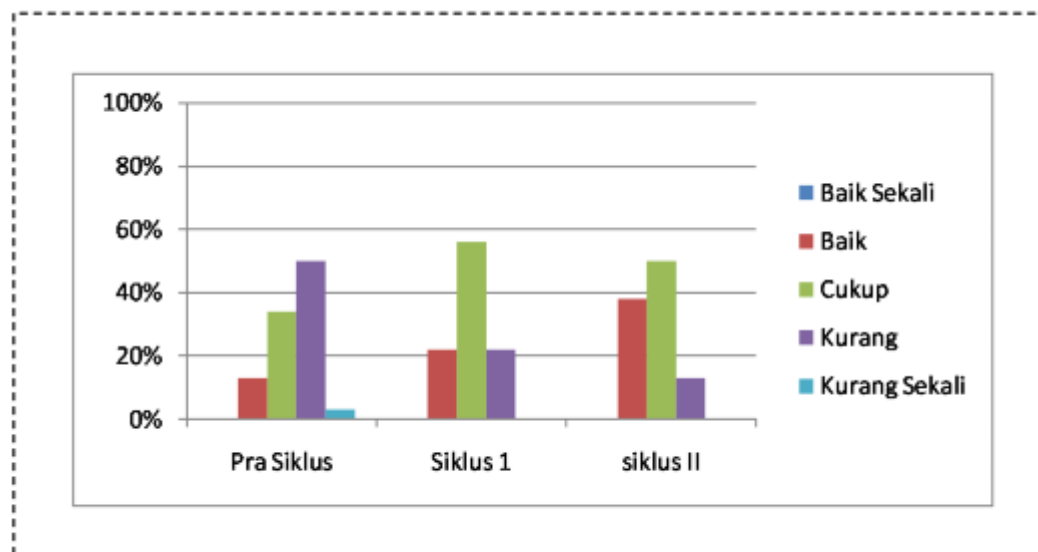

Key words: must be written in 3-5 words, separated by commas
