

COPYRIGHT ASSIGNMENT AGREEMENT

(Volunteer)

The undersigned (“Volunteer”), located at [insert address] is a volunteer with GENERAL ASSEMBLY OF THE TRUE JESUS CHURCH IN THE U.S.A. (“TJC”) and is executing this Agreement with respect to the works set forth on Schedule 1 that were created, in whole or in part, by Volunteer (collectively, the “Work”). Volunteer wishes to gift/donate the Work to TJC and is executing this Copyright Assignment (“Assignment”) to transfer his/her right, title and interest in and to the Work to TJC. Accordingly, for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Volunteer, the Volunteer hereby acknowledges and agrees as follows:

1. Volunteer hereby irrevocably assigns, transfers and conveys to TJC, its successors and assigns, all of his/her right, title interest, in the United States and in all other jurisdictions, in and to all copyrights (including all renewals and extensions thereto) in and to the Work, in all forms and media of expression now known or later developed. Volunteer also hereby irrevocably assigns, transfers and conveys to TJC all related rights, including but not limited to, all common law rights and all causes of action, either in law or equity, for past, present, or future infringement based on the copyrights and to recover and retain any damages paid or received as a result of such infringement. For clarity, this Assignment includes the rights to apply for copyrights to the Work and any new or revised, adapted, abridged versions of the Work, and the exclusive rights to print, publish, republish, transmit, display, sell and distribute the Work or any portions thereof and to prepare, publish and distribute derivative works based thereon, in all languages throughout the world, in any form or media of expression whatsoever now known or hereafter developed or invented (including without limitation any form of electronic publication distribution or transmission) and to assign and/or license such rights to others.
2. The Volunteer acknowledges and understands that TJC may exercise the rights listed above with respect to the Work or any portions thereof without attribution to the Volunteer, and the Volunteer hereby waives and releases all personal and moral rights of the Volunteer in the Work, including rights of attribution and integrity, and any and all claims of any kind against TJC directly or indirectly related to the Work.
3. Volunteer represents and warrants that (i) Volunteer has not made any prior assignment or transfer of any right, title, or interest in the Work or any portions thereof, and Volunteer will not make any subsequent assignment or transfer of any right, title, or interest in the Work (in whole or in part) to any person other than TJC, (ii) except as disclosed to TJC in writing, Volunteer is the sole author and creator of the Work, and (iii) the Work does not infringe any copyright or otherwise violate any other legal or property rights.
4. Volunteer will execute all documents or papers and perform such other proper acts that TJC may determine are reasonably necessary or desirable in order to effectuate the provisions of this Agreement.
5. This Agreement is binding upon and will inure to the benefit of the respective heirs, successors, assigns, and personal representatives of the parties hereto.
