All payments made are non refundable and non transferable, unless a Goddess Retreat is canceled by House Of Divinity due to unforeseen circumstances like Government shut downs or covid-19 pandemic. If you decide not to go on a Goddess Retreat all payments are non refundable and non transferable.

Final payment due: August 15, 2024

In the event of an unforeseen cancellation BY House Of Divinity, the Goddess Retreat will be postponed to another date and a credit will be issued for the amount available for another Goddess Retreat. The credit can be used towards the postponed Goddess Retreat or any another (non-sold out) Goddess Retreat within a 12 month period. After 12 months the credit will be null and void. Unless otherwise stated that the Goddess Retreat is canceled completely.

House Of Divinity will inform you of any/all required documentation that must be completed to gain entry into any country. Thoroughly reading all of the details provided by House Of Divinity is necessary to avoid any confusion or denied access into a country. House Of Divinity will not be held accountable or responsible for any documents missing due to not thoroughly reading. House Of Divinity will not be held accountable/responsible for any trip based misunderstandings due to not thoroughly reading guidelines and any documents sent out by House Of Divinity to participating Goddess Retreat guests.

Flights and any transportation outside of group transportation is not included.

All payments are non-refundable; however, it is transferable to another traveler for a fee of \$55. In the event you miss your monthly payment, you subject your trip to cancellation by House of Divinity, LLC without refund/reimbursement.

- CONFIRMATION: You will receive an official confirmation with receipt (including amount paid and remaining balance) on House of Divinity letterhead once full deposit is received within 24 hours of payment being received. Your spot is not secure until you receive your official receipt of payment, with remaining balance, on official HOD letterhead.
- PAYMENT SCHEDULE: After paying your deposit, your remaining balance will be broken into
  equal payments over the remaining months with the final payment due in Aug 2024. You will
  begin receiving an invoice on the 1st of the next consecutive month, after deposit is paid.
  Invoices are to be paid by the 15 of every month. Failure to pay your invoice by the 15th of the
  month will result in termination in your spot as a guest on the retreat. In the event your spot is
  terminated, you will forfeit all previously made payments, all of which are non-refundable.
- FINAL PAYMENT: Final payments are due ~2 weeks before retreat (Bali 2024- August 15, 2023)
