

Treasury Proposal: 4th Interim funding for Fellowship Secretary

Requested amount: \$22998 USD to be converted based on <u>Subscan EMA7 rate</u> **Short description:** This proposal requests a fourth round of 3-month allowance for the

Fellowship Secretary role which is currently unfunded.

Project Category/Type: Miscellaneous

Previous treasury proposals: Proposals #194, #240, #287.

1. Context of the proposal

Anaelle was formally onboarded as the Fellowship Secretary on 28th April 2024 via Proposal 103. The **initial probation period of 6 months** for the Fellowship Secretary role ran from 29th April 2024 to 31st October 2024.

A <u>Secretary collective</u> is currently under development to specify the core responsibilities, review mechanisms, and payment channels for the Fellowship Secretary.

2. Problem statement

Proposals #194, #240, and #287 have been approved during H2 2024 and Q1 2025 to pay a quarterly allowance to the Fellowship Secretary.

At the time of this proposal, the <u>Secretary collective</u> is being finalised and the Fellowship Secretary role remains unfunded in the short term.

3. Proposal objective(s) or solution(s)

This proposal seeks to allocate another 3-month interim funding to ensure that the Fellowship Secretary's monthly salaries are covered throughout Q2 2025, while the deployment of the Secretary collective sub-treasury is finalised.
