- Recruitment Strategies: <u>Current Representation</u>: Lander University, Newberry College, Claflin University, Midlands Technical College, (committed to participate) Denmark Technical College, University of South Carolina Lancaster, Eastern Technical College
- Shannon will ask MTC for at-large member to join. Shannon to reach out to Ursla Robinson at Orangeburg Technical College and Lyle to invite USC.
- Event Planning:

Ideas:

- -Public Speaking, Oral Interpretation and Debate. David Harpool (Newberry College) to organize and introduce the Lincoln Douglas Debate.
- -MaryBeth suggested grad students host workshops on design.

Concerns:

- A. Having too many events (Pat). Board decided to keep it to an even twelve events.
- B. Theatre Events: Lyle questioned policy with competitors: Undergrad only? "Seasoned" individuals such as grad students are not on the same playing field (Cedrick/Pat); Lyle: Talent is not grade-level; MaryBeth (its subjective).
- C. Lyle: Safety/shenanigans should tournaments be combined. If all three divisions are together, how can we protect the students? David Harpool, Esq., was invited to the meeting via Zoom after lunch for Q & A. Lyle stated that he would leave the board if combined tournaments due to potential legal ramifications. Solution: Orientation material- bring chaperones, must put in safeguards, have a layer of protection as a waiver to not hold SCSTA accountable.
- D. Discussed benefits of combining festivals: only one commitment, younger students can be influenced positively and can see older students as goals, save resources, education (college workshops). There is no reimbursement for personal money used for hotel, gas, time for multiple festivals so this opportunity would prove beneficial on every level.
- E. College division piggybacks off of the high school division: If we do not combine, the college and middle school divisions struggle to exist due to lack of funding. MaryBeth questioned, "WHAT IS THE GOAL of this program?" Important to remember that we love theatre, speech, students, exposure, and growth- if we remain in the spirit of the art, there should be no problem. We are a nonprofit organization. It's "Mission not money" (Gagliano). Remember the mission as we pour into the students; "the mission should drive what we do" (Grievous).
