

Informal vs. Formal Writing

Use informal or formal writing depending on the **purpose** and **audience** of the task.

Formal language is less personal than informal and should ideally take an objective, non-combative tone. Types of writing that use formal language are academic papers and graduate school assignments. It does not use contractions and mostly uses third-person pronouns.

Informal language is put into use when talking to friends or family due to its casual and spontaneous nature. Text messages, personal emails, and some business correspondence typically use informal language. It takes less time and can sometimes be more succinct in getting a point across since there are no restrictions.

Avoid solely using <i>this/these</i> . Use <i>this/these</i> plus a summary word instead.	Professors should actively involve students in lectures. This will help students retain more information.	Professors should actively involve students in lectures. This engagement will help students retain more information.
Limit the use of "run on" expressions, such as: and, so on; etc.	Examples include roses, tulips, daffodils, etc.	Examples include roses, tulips, daffodils, and other flowers.

Limit the use of coordinating conjunctions (for, and, nor, but, or, yet, so) at the beginning of sentences.	And the study also compared	The study also compared
Academic writing does not typically utilize the first-person (<i>I/me/mine</i> or <i>we/our/ours</i>), or at least limits its use. Avoid first-person pronouns unless your field of writing frequently uses it, there is a specific writing genre (e.g. personal reflection), or it is only in certain parts of the paper (e.g. in introductions to state the purpose of research).
