2. Methodology

Tables should be created using the Table function in MS Word. All tables must be numbered using Arabic numerals followed by a period. Table titles should be written in Palatino, 10 point font, with only the first word capitalized. The word “Table” and its number should be in **bold**, while the rest of the title remains in regular font. The title must be placed above the table, centered, with 6 point spacing before and 6 point spacing after. Tables should not contain vertical lines or shading. All table contents must be left-aligned. The table width must be adjusted to fit the page width using the “Fit to Window” option in MS Word.

Sources and notes should be placed immediately below the table, in Palatino, 8 point font, left-aligned.

3. Result and Discussion

Figures should be inserted into the text in *.jpg format and centered on the page. Each figure must have a minimum resolution of 300 dpi. All figures must be numbered sequentially using Arabic numerals followed by a period. Figure titles should be written in Palatino, 10 point font, with only the first word capitalized. The word “Figure” and its number should appear in **bold**, while the remainder of the title remains in regular font. Titles must be placed below the figure, centered, with 6 point spacing before and after. Subfigure titles should be incorporated into the main title using labels (a), (b), (c), and so forth. Sources and notes should be positioned immediately below the figure, written in Palatino, 8 point font, centered.

Equations should be written using the MathType Equation function in MS Word. Each equation must be accompanied by a number indicating its sequence, placed on the right margin. Explanations of notations must be provided immediately after the equation, preceded by the word “Where:”.

4. Conclusion

References should be written in Palatino, 9 point font, with the second line indented by 0.75 cm and single spacing. The reference entries must be arranged alphabetically (A–Z) based on the author's last name.
