



Acknowledgement of Risk, Waiver, and Release of Liability

I hereby give my permission for my child(ren) to participate in activities, events, or programs conducted by ILY2 LLC, d/b/a ILYouth2 (the "Camp").

Accidents and injuries are always a possibility, and despite reasonable precautions, it is impossible for the Camp to enumerate or eliminate all possible risks or guarantee safety. Camp staff and contractors are authorized to act in their reasonable judgment in any situation requiring medical attention for my child(ren), including without limitation, administering first aid and, if necessary, calling an ambulance for transport to a nearby medical facility. The costs of any transport or medical treatment is my sole responsibility regardless of whether the costs are covered by my medical insurance.

I hereby affirm that my child(ren) has/have no conditions that would make it unsafe for him/her/them to participate in the Camp's program(s).

I understand that Camp staff may exclude my child(ren) from the Camp in the event that I or my child(ren) fail to abide by the Camp's health and safety protocols, disrupt, impede or interfere with the operations of the Camp, or threaten the health, safety or welfare of other participants or Camp staff, and that no refund of any fees will be made in such circumstances.

I understand that while participating in the Camp, my child may be photographed. The Camp may use my child(ren)'s, likeness, voice, artwork, and biographical material in connection with any legitimate purpose, including website and social media publication, and business promotion. I understand that no royalty, fee or any other compensation of any kind shall become payable to me by reason of such release and use.

By signing this Waiver and Release of Liability, with full appreciation of the risk involved, on my own behalf and on behalf of my child(ren), I hereby voluntarily release and forever discharge the Camp, its staff, employees, agents, insurers, and contractors from any and all legal or financial responsibility for any personal injury, disability, illness, damage, medical expense or death, arising from or related to my child(ren)'s participation in the Camp. I agree, for myself and my child(ren), not to make any type of legal or equitable claim on the Camp, or any of its staff, employees, agents, insurers, or contractors with respect to any injury I or my child(ren) may suffer, whether or not it arises through the negligence, omission, default or other action of anyone affiliated with the Camp, including other campers. I further agree that if any such claim is made, I will indemnify and defend the Camp with respect to any such claim, injury or damage.

ILYouth2 Drop-Off + Pick-Up Policies

AUTHORIZED ADULT.

For safety and security, during registration the parents/guardians must designate an 18+ adult(s) who is authorized to pick up your child. If anyone other than the authorized adult will be picking up, this info must be shared in written form by the parents/guardians, via signed note or email to daelyn@ily2online.com

SIGN IN / SIGN OUT.

Campers must be signed in and out. Sign out requires an authorized adult with a legal photo ID. The only exception to this is if the camper is authorized for independent release. Campers will not be permitted to leave ILYouth2 without being properly signed out.

INDEPENDENT RELEASE.

We recognize older youth may arrive at ILYouth2 independently. Parents/legal guardians can sign a waiver that allows youth to check themselves in and out. Please contact daelyn@ily2online.com to set this up.

EARLY DROP OFF / LATE PICK UP.

We do not offer early drop off or late pick up options at this time. There is a \$25 late fee for youth who are picked up 20+ minutes past the end of their registered programming.

PARENTS / GUARDIANS.

Authorized adults are permitted but not encouraged to stay in the ILYouth2 space during your camper's programming. Only campers and ILY2 LLC and ILYouth2 staff are allowed in the studio area and restroom during programming. There is limited space in the ILYouth2 shop / gallery area. If you'd like to stay in the Lloyd Center, we recommend checking out ILY2's artist residency space ILY2 Too, any of the mall's great independent stores, or hanging out in any of the mall seating areas (both the ice rink and the 3rd floor food court have tables).



ILYouth2 Payment Policies

REGISTRATION.

Registration is required for ILYouth2 camp participation.

PAYMENTS.

ILYouth2 uses a tiered payment structure. We encourage folks to consider their privileges and capacity when selecting a tier. This enables us to pay our working artists instructors a fair wage, while ensuring our programming is financially accessible to families. REFUNDS.

We cannot credit, refund, or prorate tuition for scheduled absences, no-shows or days missed due to illness or injury.

- Cancellation 80 days before program begins: 65% of tuition is refundable.
- Cancellation 60 days before program begins: 35% of tuition is refundable.
- Cancellation 30 days before program begins are non-refundable.
- All refunds are subject to a 3% processing fee.

If ILYouth2 must cancel *before* the start of a program session due to weather, health orders, or civic mandates, you receive a 100% credit for another ILYouth2 program in the next 12 months.

If ILYouth2 must cancel *before* the start of a program session for any reason NOT due to weather, health orders, or civic mandates, you receive a 100% refund paid to the original payment method or as a credit for another ILYouth2 program in the next 12 months.

If ILYouth2 must cancel *after* the start of a program session for any reason NOT due to weather, health orders, or civic mandates you receive a prorated refund or as a credit for another ILYouth2 program in the next 12 months.



ILYouth2 General Policies

PHOTO RELEASE.

ILY2 LLC and ILYouth2 staff and contractors regularly take photographs, audio recordings and videos of participating youth, and retains all rights, title and interest therein. ILY2 LLC and ILYouth2 take care that use, display, and dissemination of these materials are accomplished in a thoughtful and safe manner. In addition, they may be used by ILY2 LLC and ILYouth2 for general business and marketing purposes, including online. CONDUCT.

ILY2 LLC and ILYouth2 reserve the right to terminate their relationship with any child, family, or individual in appropriate circumstances. Activities warranting termination include, but are not limited to:

- failure or refusal to abide by ILYouth2 policies or regulatory requirements;
- failure or refusal to accept and cooperate in ILYouth2 decisions or practices;
- bullying, physical abuse, or verbal abuse toward staff, children, or others, including racial slurs, hate speech, cursing or swearing;
- inappropriate, discourteous, or disrespectful interactions toward or communications with others, including on social media;
- failure to pay registration; or
- demand for special treatment or services that are not provided to others, cannot reasonably be delivered by the program, or are outside the philosophy of the program.

ILY2 LLC and ILYouth2 will attempt to discuss its concerns and allow a family the opportunity to correct inappropriate or disruptive conduct. However, the nature and/or severity of the conduct may require immediate termination. If a camper is engaging in disruptive or unsafe behavior, ILY2 LLC and ILYouth2 will contact the parent/guardian on file, and may request early pick up.

While ILY2 LLC and ILYouth2 cannot eradicate the possibility of conflict or harm, they will not hold space for transphobic, racist, ableist, or other oppressive behavior.

WHAT TO BRING / NOT BRING FROM HOME.

Campers are prohibited from bringing valuables, animals, illicit substances, weapons or contraband. Campers *may* bring personal cell phones, but may not have them out during ILYouth2 activities, unless necessary for specific programming and approve by the instructor. ILY2 LLC and ILYouth2 are not responsible for personal property that campers, staff, parents, or other individuals bring into our space. Please note that we do not have space to, and cannot, store personal items, including bicycles, car seats, etc.

ABANDONED ARTWORK

ILY2 LLC and ILYouth2 will attempt to hold onto work for a week after programming, but are not responsible for work that is not taken home at the end of registered programming. Work that has been at the ILYouth2 for a week beyond the end of registered programming will be considered abandoned and will be handled at the discretion of the ILY2 LLC and ILYouth2. ILYouth2 Health Policies

HEALTH INFORMATION.

Families are responsible for providing accurate and complete medical, behavioral, allergy, and dietary restriction information critical to their child(ren)'s safe enjoyment and participation in ILYouth2 activities.

FOOD / FOOD ALLERGIES.

When applicable (typically: full day camps), youth are required to bring a lunch and/or snack from home, which does not contain nuts (including peanuts, nut butters, almond milk, granola/candy bars with nuts, etc), is ready-to-eat (since refrigeration and/or heating are not available) and is clearly labeled with the child's name. ILYouth2 does not provide lunch. ILY2 LLC and ILYouth2 are unable to guarantee that snacks and lunches brought in by other campers or staff are safe for exposure to or consumption by children with food allergies.

SICK CAMPER / WHEN TO STAY HOME / COVID 19 / MASKING.

Youth must stay home or be picked up promptly if they exhibit, have exhibited, or have been exposed to any of the following within the last 24 hours:

- fever, cough, shortness of breath, sore throat, chills, body aches, fatigue, headache, nausea or vomiting, diarrhea, new loss of taste or smell or eye drainage.
- symptoms of a contagious disease or illness that presents a risk to others, including COVID-19, unless the child's regular physician confirms the child is not contagious or the contagious illness has resolved.

Additional measures may be taken depending on the medical circumstance as required by local health departments, the CDC or other public health entities.

In some cases, specific ILYouth2 activities, events, or programs may require masking. These will be clearly marked in the programming information. In general, please be mindful that wearing an N95/KN95 is the best tool to reduce the risk of spreading any virus, which protects our whole community—particularly immune compromised, chronically ill, and disabled community members.

Youth and adult sized masks are available at ILYouth2.

IMMUNIZATIONS.

For the health and safety of all campers and staff, all attending child(ren) are required to be current on all immunizations required by their local school district (including COVID-19 vaccinations). Proof of vaccination may be requested at any time. Exceptions for non-medical, religious, or philosophical reasons are not permitted, except in states where consideration for exceptions are required by law. Medical exemptions will be considered by ILY2 LLC and ILYouth2 staff on a case-by-case basis with adequate documentation from the child(ren)'s regular, licensed physician confirming that they cannot safely receive vaccinations for medical reasons, in addition to information needed to meet any applicable state requirements.

MEDICATIONS.

We do not directly oversee medication administration at ILYouth2. Campers must bring medications in original packaging, labeled with name and dosage, and keep them in their backpacks. If your child has an EpiPen or inhaler, they should carry it and inform the instructor of its location for emergencies. Campers are responsible for self-reminding and self-administering medication during ILYouth2 activities.
