#### **Announcements (including some from Match)**

- Comments about need for decorum at neighborhood meetings. This is a 100% volunteer organization, can only be what we all agree to do.
- Please contact Mayor Jones administration asking they agree to release funds to Building Commissioner to stabilize 1000 Morrison against collapse. Funds are now available from ARPA and also Rams settlement.

#### Alderperson Updates from Jack

- Board of Aldermen in recess, but still working.
- City has an open survey right now asking for citizen input on ARPA funding use:
  - We have broad leeway what uses can be, anything related to pandemic disruption
  - Be aware no requirement a minimum % be used in particular wards, not like ward capital funds
- 2<sup>nd</sup> installment of ARPA funding dispersal discussion, at present a lot is mainly earmarked for distressed biz districts in north St. Louis
  - Jack wants a lot used on Soulard Farmers Market
- New legislation for NGA complex and adjacent zoning changes.
- Graffiti on overpass and stop sign cleaned up
- Still waiting for Streets Dept to put more boulders at Mall entrance off Park, replace burned stop sign at off-ramp
- Please call police about people driving on Mall
- MoDOT to visit unhoused camping under overpass
  - Jack mentions success of tiny house project at MLK and Jefferson, tentative support for similar in 7<sup>th</sup> Ward
- Water Division working to triage water pipe leaking under Mall near Park Ave, reminder to please not cover with aggregate. Neighborhood can muster volunteers to put bricks back, if that's what it takes.
- Badly busted up curb at 9<sup>th</sup> & Hickory still on list of stuff to fix
- Discussion of Association taking control of land under overpass, similar to how Clean has a parking lot.
- Still unknown when alley recycling collection resumes, uncertain if materials collected can even find vendors

#### **Neighborhood Improvement Specialist Mauria Tomlin**

- Asking for license plates or description of cars driving on Mall, can also follow up with housing management
- Clarification Mauria's purview is the entire 7<sup>th</sup> Ward, just like Jack
- Mauria is liaison to city services, e.g. health & human services for unhoused encampments, refuse department

#### **Public Safety Update**

- From PO Chris Murray: There were 11 Part-1 crimes the past 30-days compared to 15 in the 30-days prior, or a decrease of 26.7%. This same period last year had 9 Part-1 crimes or a 22% increase (9 to 11) this year.
- Overall, there have been (35) part-one-crimes thus far in 2022 in LaSalle Park. There were (23) part-one-crimes at this point in 2021, or an increase this year of 52%.

### LaSalle Park Community Association (LPCA) 501.c3 Update

- Have reviewed Bylaws, conferred with counsel
- Introducing new **Neighborhood Officer** role
- Use of 501.c3 nonprofit status has to be cleared with board, they bear liability for it
- The 501.c3 is structured to require agreement/cooperation of majority of board members. Absent that consensus, very hard to get anything done.
- New (draft) Mission Statement for website, etc
  - Perhaps more explicit language about encouraging cooperation among neighbors
  - Draft and the full language from 501.c3 application quoted below
- Clarification about 501.c3 board membership determined by vote of existing membership. The org is by necessity a private non-profit corporation, not chartered by the city. Neighborhood Officers and Committee membership is a pathway for residents to get involved, develop working relationship with board of directors. Establish rapport to later become voting board member.
- Current 5 board members: David B (President), Jenn S (VP), Marcia G (treasurer), Ben W (secretary), Danielle F-S (board member)
- Explanation of 3 year term, desire to later amend bylaws to shorten term and other details.
- Paperwork filed so that "LaSalle Park Neighborhood Association" is fictitious biz name for LPCA.

#### New Mission Statement

The new 501.c3 Community Association needs a Mission Statement, ideally concise yet clear. Here is our current draft:

We strive to unite and engage the diverse residents of LaSalle Park in a common vision to beautify our neighborhood, preserve its historic past, and deepen relationships with public officials.

For reference, here is the full language from our 501.c3 application:

#### 2. Charitable and Educational Activities

The primary activity of the Organization is to organize and sponsor events within the Community to engage volunteers in projects to improve, preserve, beautify, and maintain the Community's public and historic spaces. The Organization will focus on clean-up and preservation efforts in the Community's public parks and thoroughfares to promote the continued use of such areas for public recreation. The Organization will also focus on restoring and preserving the historical architecture of the Community, as well as encouraging appreciation of the historical significance of the Community, for public benefit and enjoyment. Although the Organization will not engage in legislative activities and will not support or endorse candidates for public office, the Organization will deepen relationships with the elected officials in the area to achieve a common vision for the Community that encourages preservation, restoration, and stabilization of the Community.

Through these activities, the Organization aims to foster civic pride and cohesion [among the varied demographic populations of the Community]/. The Organization seeks to foster cohesion and unite all residents of the Community to create a common vision for the Community that simultaneously celebrates its historic past and embraces the evolving needs of the Community's residents. In addition, the Organization will seek to foster unity among Community residents by hosting social events and recreational activities to build relationships and lessen neighborhood tensions. Specifically, the organization [seeks to unite residents of varying races and backgrounds through these activities to bring together the residents that are physically separated by the Pedestrian Mall]./ This will set a good example and educate youth in the Community as to the benefits of diversity and inclusion to achieve a common goal and overall stronger community. The Organization will educate Community residents about services offered by the City of St. Louis and [develop educational materials to promote crime prevention awareness and further unite and stabilize the Community.]/ The Organization has already undertaken efforts to unite the Community by establishing a Community herb garden, compost pile, and a monarch butterfly migration garden, each of which is open to the public.

Finally, the Organization seeks to aid the Community's population of transient residents by developing educational programs (e.g., brochures, web-based materials) designed to raise awareness of, and increase access to, social services available to such residents within the Community and the greater St. Louis metropolitan area.
