2019

The KCS Board of Education held a Special Meeting on Monday, October 21, 2019, at 5:00 pm, in the Principal's Conference Room. In attendance were BOE members Marty Lindenmayer, Scott Trabucco, Melissa Roth-Cherniske, Dana Slaughter, Jenn Duncan and Gonzo-Garcia Pedroso. Also in attendance were KCS Principal Michelle Mott, Region One Business Manager Sam Herrick and reporter Lynn Mellis-Worthington.

Marty Lindemayer called the meeting to order at 5:00 pm.

1. Review and acceptance of the 3-year Contract between the Kent Center Board of Education and the Kent Education Association. Jenn Duncan made a motion to ratify the July 1, 2020- June 30, 2023 Certified Teachers Contract to include the following; a quiz bowl coach at \$259.00, a student council advisor at \$259.00, a PTO coordinator at \$259.00, a field day coordinator \$360.00, a grade 5 / 6 basketball coordinator at \$369.00; a team mentor at \$559.00. This will be a 3.3% increase each year for all three years. Health and Dental premium will increase .5% each year for all three years. A secondary observer position has been added at a rate of \$37.00 per hour for the 2020-2021 school year, \$38.00 per hour for the 2021-2022 school year, and \$39.00 per hour for the 2022-2023 school year. Melissa Roth-Cherniske seconded the motion. The motion passed unanimously.
2. Discussion regarding the proposed Region 1 Middle-School Sports Initiative and planning for a KCS Town Hall. The KCS Board of Education will hold a Special Meeting on Monday, October 28, 2019, at 6:30 pm, in the Kent Center School Library. The purpose of the meeting is to hold a discussion regarding the Region 1 Middle-School Sports proposal.

The meeting was adjourned at 6:30 pm.
