# Sandy 02:39

Okay, so in September 89, I gave birth when they were my six and seven. And what happened was, I've been wanting to leave the cult for a long time. But I couldn't because my husband, and it would always be the same thing you can go but the children stay that was always you know that the teaching of the cult, it's very difficult to leave if your partner doesn't want to leave because you end up losing children. All of them, some of them. And I was never willing to do that. Because that had already happened. First husband left. And he lost me. His two little girls. We either we'd already had that experience. What country were you in? This was in Australia. So now failure. We had been in India we come we've been in India for six years for maybe 288. I had my twins in 89. And this was basically April May 1990. And so one of the twins. They gave me morphine in the hospital. And it was undiagnosed, but because I have had manic episodes since then, I think that morphine gave me a hypomanic episode. And it made me realize I wasn't sleeping. I wasn't getting any sleep for months, feeding through babies, I was under a lot of pressure because I still had to do my work and looking after my group. You know how children were put in groups. I had I had three and four year olds and two, two babies. Anyway, what happened was, I just I wasn't sleeping. I was hyper manic, and it just made me really, really assertive. And I got to it. I could not take any more criticism or bullshit at all. It was a very tumultuous time I did a lot of crying. I really was in the midst of of a breakdown and

so the day I left I I had been summonsed before the leader, the leader of the area, named Aaron, and the leader of the household named Gideon, and my husband and I had been in like, the room with my little group, my little babies were already in the nursery, the nursery, another mother and a couple of jet age girls, were looking after my twins and other babies. And I knew I was in trouble because the week prior, they had a parent teacher meeting. What about this, we've all unhappy the children were getting enough schooling, and we're just getting too much indoctrination. And my daughter's in particular, was not coping at all with being separated from me, and was not coping with all the pressure. And so in that meeting with the, in the parent teacher interview, I complained, I'd said, Look, you know, she still can't spell. When I was called before the leaders, I knew that it was very hazardous to symbol you will. So, you know, for the most part, people wouldn't become. But anyway, because this was so important to me, I did speak up. Anyway, I got called before these three men, my husband getting in an errand, and it was very intimidating. And I was so annoyed, I wasn't getting any sleep. I was breastfeeding to bed. I had these little children, I had to look up to every day. And I just was in no mood to be challenged. And basic. Look, you know, you're speaking to you first, you know, there were other mothers who have a lot more to say that wasn't the spirit. And no, I'm like, Well, I'm just, I basically let them know, I'm fed up. I've had enough. And the leader, he's, he came down pretty hard on me. And he said, you know, if you you know, you're gonna have to get the victory, or you're going to have to leave the family

and getting the victory. I don't think they really understand what that means.

he said that. It was it was a light bulb moment. Because I wanted to leave family. I am trying to leave the cult for years, but I couldn't. Because my husband wouldn't. And and I just said, I want to leave, I want to lead. And, you know, they were very taken aback by that. They expected me to say, oh, no, don't you know, I'm sorry. Don't kick me out. I want to serve God. You know, they expect that but I'd have enough. I'm like I want to be and the leader, here's what you will do. You will take your babies and your your, your, your little bunch or at the time, and you will go to the household of some some people who had left the cult was sort of harping about halfway house. Yes, yeah. And he said, you go there, and you will pray and read the word meaning read all the letters. And you know, then we'll decide what to do with you. I just stood up for myself for the first time in my whole time in the Colts. And I said, I'm going I'm taking my

babies, and I will take my eldest, and I will be back for the rest. And that was it. I'm like, I've done it. I've done it.

I'm, I'm leaving. And that was the morning I left. And what was keeping me there was my own mind. Your fear? Yeah, exactly. Exactly. It was my own fear. My own feeling that I couldn't trust my own. I couldn't trust my own wisdom. No. Yeah, it was a huge turning point. And that was the day I left. But do you know thought of that instance many times and I'm like, Why did I just say, I'll take my eldest or my babies? Why did you say, on every single one of my children right now? I can ascertain, but not a complete breakthrough. I reply that in my mind, because I was then faced with the difficulty of my husband, Daryl being in the cold with the rest of my children, you know, they were scattered, that my older two were in another household. And, yeah, it just didn't occur to me to say, I will take all of them up, I think, because he'd said, you take your younger one and your babies, and I thought, well, that's not good. I can't manage three little ones on my own. You know, and, you know, figure out what to do. So I said, I take my eldest because she was my appeal. Yes, she could help me, my eldest was my children's best mother. Okay, so what happened was, I was sent to the household of a couple who had been basically kicked out of the cult, because the husband of this couple was a predator. But nobody told me that, like EDA sent me and might be children. I've been molesting his daughter. And I don't know if he had molested other children. I don't know. But they knew that the leader knew. But he still sent him. And he put me in a very dangerous situation, he put my children and I in a very dangerous, and I didn't know nothing to my children, when we were in that household that could have I wasn't told, that was another thing that replays in my mind. Yeah, it's such a lack of respect for me, and for my children, to just send me to a household with, with the leading knew that that man had, was a sexual predator. When when I found out when I went there, his wife, you know, as soon as I arrived, I was very excited. Because, you know, I was on a mission to get my husband and the rest of my children out. And, you know, an interesting thing about the cult, everything. It's very what is very similar to what we hear about Catholic Church, if it comes to the attention of the hierarchy, that one of the priests is preying on children is a sexual predator, they just move them. They don't report him to the police. They, you know, they don't say, Well, that's it, you know, we're calling the police. No, they just moved them from one place to another to another. And that's what the cult you know, they're taking the law into their own hands, at the, the risks and at the expense, exactly. At the expense of their own children. God has always sacrificed its children. It's women. It's not, you know, it's people say to us what it's all about sacrificing your life. All your resources, your time, your energy your children, to this cult of David Berg. It's what it is. It's a sacrifice cult. Because that's exactly what happened. That's exactly what we did. This is the thing as being a first generation member, you know, admittedly, I was young when I was recruited. But I this is an interesting topic of, you know, why do good people do things? And, you know, so much has to do with environment, if you put a person you know, with certain morals into an environment where where the morals of different you know, they adapt, yeah, that's what happened. We, we joined and we adapted and changed our beliefs, our standards or morals or ethics. takes our worldview, attitude. We changed everything in order to fit in. But in fitting in, we were harmed. And so we're out. But we still did it.

But Sandy, I was wondering, so when your parents allowed you to get into this call, and now that you're getting back out, were they there to support you when you stepped back into

the real world? When when I notified them, because I have a lot of shame about, you know, I hid a lot of things from my parents, I had a lot of shame about this cult, I didn't know, I didn't see it as a fault. But I knew that. But, you know, I felt I'd been a bit to my parents for years. And they were always having to send me money and rescue me. And, you know, like, for example, when we were in India, they sent us money to return to Australia. I was in Thailand, money returned. You know, so I always felt like I was being a problem to my parents are a burden. Yes, a burden. So I didn't notify them. Until there was a big issue between my husband and I, because he he eventually came to do what the leaders did, they told when when I got the fight was on to

get my husband and my children. And so I was ringing every day, and knew that, like, a lot of people didn't know the phone number of the actual Apple they lived. I did. And I would ring. And I would take, I want to I want to have bring my kids. And, you know, I want to sit or do you know, I love Jesus, you know, you've turned your back on God, you know, like, I, I lose my temper, and I am the bone down. And then I began and bring again. So my children have told me since you know that that was very unnerving. You know, the phone would ring and there'd be this argument. And then, and then bring again, everyone was very unknown.

Did were you able to ever talk to your family members, like an aunt, or sister or brother? And kind of get their perspective on where you've been all this time? And what they felt about your life decisions?

Yes, yeah, I have. Well, both my parents have died. But one younger brother, but yes, yes. And the older, you know, the years since I left, I would have conversations mostly with my father, about, you know, because he would basically say, you something wrong with you. Like, you know, my father was very supportive of all the years I was in, I had relatives who would say to my dad, just forget about her, just, you know, like, she's gone and done something to really harm your family. You know, just leave up, let her get on with it. Let her learn the hard way, look, see what she's done. But my father would be like, No, something's happened to her. She's different. She's not herself. My father could see that, that I wasn't thinking for myself that whatever the children of God did to me, in those very early weeks of my having met them, it set me on a completely different path, and was utterly out of character for who I was and what I was, and he could never understand that he knew was something about my mind that had been affected. So my dad, I adored my father, like, he was a very intelligent man. And he approached the whole, the whole problem with great caution. And he never, you know, there were times when he, you know, be annoyed with me, and he would tell me, so, you know, this was when I was in, in the early years when I was in the cult, you know, he'd be frustrated with me. But yeah, my father could see that I wasn't thinking for myself that I was in a relationship where I was being exploited and abused. And yet I didn't leave that relationship and that my children were suffering. You know, the consequences of me, their mother not being able to stand up for them. I was fortunate, my father. He never gave up on me. I think my mother's the same, but in a different way. My mother supported me in a different way. I come from Liverpool in the UK, and We're what you call Liverpool, Irish. And they're very clannish people. And so

you're always what are your siblings? What did your siblings think when you know, like, now? Are they you know, are you still in communication with them? Um,

well, what happened to my siblings is, their lives and the lives of their children were all put on the back burner. Because I took center stage me, you know, like, it was hard for both of my my siblings, because when I joined the children of God, not only did my life change forever, so did that. And, you know, they have said that, you know, one or two things that, you know, we became invisible because of you. And because of all your, it was

all about, Sandy is all about Sandy's kids. And

you needed rescuing. So you became front and center? Oh,

yes, I Yeah. And even after I left the cold, I lived very close to my children, to my parents. I knew too, that I could live close to them. And so my father could walk to my house. And he did every day, he walked up my house with his little dog. And so he was always there, my mother would always come, she was always helping with cooking and cleaning and looking after the children. And so for my parents to visit, my brother and my sister and their families, they had to go on and drive elsewhere, whereas they could walk around the corner, and I was there. So they were very, in very, very present in my children's lives. And so we're very close to them. And yeah, my it. So it's not just the person who joins the cult whose life is changed. It's the lives of parents and siblings and relatives. And it's like, you know, the story of throwing a stone in a pond. The implications of it, just go on and on and on throughout time.

The ripple effect, the ripple effect, yeah. So when you left, how long did it take for you to get the rest of your kids back?

Okay, so it actually only took a couple, maybe two weeks, because I was, you know, I was very much on a mission. I have to get my kids I have to get my kid to every day. I would assign my eldest, my oldest daughter to look after the twins, keep them in the bedroom, feed them, there's their milk. I've got to go out but I'll be back. And yeah, I I just I didn't tell anybody. At first. One thing that did happen was I saw an advertisement for a helpline. In a strip here in Australia. It's called lifeline says if you've got a problem is something going on in your life. And I'm reading it I'm like, yes, yes.

And so I rang them, I'd write down the phone number, and I rang them, and I was, but I couldn't tell them about the cult. I'm saying, I put these children, my husband's are feeling sila. Yeah, like terrified, you know, to say anything. And she's saying, Well, are they your children? I might, yes. Like, we're gonna get them on like, well, I can't, because they, you know, I hung up the phone, and I'm like, oh, you know? And I'm like, No, I'm

gonna try again. So I pick the phone up, call, again, be a different person. And I'd say, look, I've got this problem. My husband has my children. He won't give them to me. He won't come to me. And no, and I'm like, and they're like, Oh, why don't you just go there and get them? And I'm like, Well, it's because it's a cult. They're in a cult. It's a group. So I said, I'm like, Oh my God. I thought this guy would fall down on my head that maybe he could go kill Boom, but it didn't. And, and I'm telling the Woman Yeah, it's a call we've been in OB was in a call to my father, my husband still with most of my children by call the police. And I'm like, yeah, so it was a process of me reaching, you know, breaking free in my mind, you know, opening a door and I'm like, Okay, I will go this far, and then opening another door and like, Okay, I'll go that far. So I was bringing the court after that saying, If you don't give me my children, I will call my dad. And he'll come down from Brisbane. And I will call the police. And give me my kids. And, yeah, so the leaders today might, where I was living. And because I gave an ultimatum, I said, If you don't, by 11 o'clock, I'm calling the police. And so next morning, just at 11 o'clock. And, you know, really angry, like, very fierce, very furious, and I'm like, You, I was furious. I was more furious. It's just insane insanity to all of this, that when people hear it, they're like, they're your children, you know, but just go and get them. Like, who do they think they are? Do you know? Like, just do it. What happened was after that, I think that was like maybe a Saturday, the next day was Mother's Day. And they said, Okay, your husband, and the kids will come. And so I met them at a park. They came in a taxi. It was my husband and I we were all together. And it was a very cold wet blustery day. But it was such a wonderful day, because we were all together again. And the children were all happy to see each other and they running around. And, and very sweet with my husband, I'm like, I love you, you know, we can be a family. I want to serve God, you know, you are backslider. And like, no matter what I said it like, it was very frustrating. Because it's obvious the children want to be together, they love each other. Yeah. In the end, the the cult leaders, they said, look, go with her, but help her find somewhere to live. They gave him money from to rent your house, find somewhere to live, get her set up, and then get her to sign paperwork, giving you half the children. So you can come back and serve the board in the family. So I was excited about that. That's fantastic. And we found a beautiful house. It was very clean. It was lovely. We were so happy there. But, you know, the fight was on between him and I who was going to win? Was I going to be able to convince him. No, let's play house, let's cook and be that children and watch TV and go for walks and or, you know, a you Uganda when but so the pressure was on. And it was it was very hard because he would not give up. And he pressured me and pressured me. I want to serve God, I want to serve the family. And he was very depressed. He became very depressed. And he would read all the MO letters and listen to the CDs and you know, the tapes and everything up. Yeah. And I'm like, oh, that's that. That's that literature that's making him miserable. So when he went out because he would go out for a few hours at a time meet up with the cult, with the leaders and you know, talk about me and what was happening. When he was gone. I get some of the material and some of the tapes, rip them up, break them, put them in the bottom of the outside rubbish bin put lots of

rubbish on top of them. And when he'd come back, you'd be saying our waste such and such and I'm like, I don't know, where did you put that and went I was hiding things or getting rid of them. And yeah, but they came to the point where he really put me under pressure. And he was arguing I was cutting vegetables at the sink. And I have a knife in my hand and he and Yeah, he was very just would not stop. And yeah, I just I had that knife and I just, I had this clash of myself stabbing him with this knife to make him stop. And I heard this like voice in my head, like, you know, you do that you go to jail, and he'll take all those kids back to the cult. And I just I pulled the drawer open, I threw the knife back in it slammed the drawer, and I picked up the phone, and I called my parents. And I'm like, I can't cope. I can't manage this situation anymore by myself. And that was when I found my mother. My father was away at sea. And I called my mother and I said, Mom, we left the family. wants to take half the kids, there's a lot of trouble, will you call and she said, I will come immediately. And she did. She came, she flew down from Brisbane to Melbourne arrived the next morning. And that was the beginning of us sorting it all out. But actually what happened that after that phone call, I was still so furious, that I still wanted to kill him. And you have to leave the house, I can't bear to look at you, I was murdered. So I really was and yeah, so he ended up taking the tu, tu tu the younger ones. Back to the household, where I had been staying when I first left the cult. And I said you just have to go because like, anyway, I kicked him out, basically. And my personality at that point was very angry, everyone was scared of me, my kids were terrified of me. Because that your fury and such a fear and anxiety, I could not control myself, it was really tough. Like, I was ready to kill everything else. Like I was just too much pressure what

I like when you have a divorce, you know, you have a divorce, you kind of go through those stages of grief, where you're angry, and then you're sad, and then you're depressed, and then you're angry again. And then you're you know, you go through cycles, and you're probably going through all of those cycles and emotions all at the same time. And, and fear as well, because you don't know what you're gonna be how you're going to be able to feed your kids and you know what you're what you're gonna do to support yourself, you know, I mean, there's all these anxieties and fears that could start to percolate. And I remember being the same way whenever I was a teenager, I was always very angry and, and very resentful to my father because I didn't understand what the hell he was thinking. By staying in the group, or by, you know, giving my my brother's out, basically, in essence, because they basically told him the same thing. Go and find your children a place to stay. And then when you're done, you can come back.

I know, it's crazy, isn't it, the things that were demanded of us as members, like, obscene it like we're being told to break up our family to, to farm our children out, you know, to, to give them up to get them up for the Lord's work. It's, it's such a travesty of justice. And

Did you guys wind up moving back to Brisbane, or what happened from there?

I'm just here to look after these kids, which is actually very Liverpool sort of thing to say, like, you know, you're crazy. But I'm just going to be these kids. And we're just going to, like, you know, I'm here to look after the kids basically. So having my mother there really helped me settle down. Because I felt I felt safer with her there. I knew we had him out numbered. Even though my mother was annoyed with me and angry with me. I, I we had two women working together to look after these children. Well, up until

And that sounds very foolish to me now. Because there was no such thing in my in my worldview, you know, but the indoctrination of God will judge you, God will deal with you if you leave the family if you harm God's work. So yeah, I My mind was very, it was a lot of turmoil. But having my mother there gave me confidence. It was very grounding, who was very grounding, having her there. And what we did, I'd already started going to a local church was the same kind of church my mother went to, because even I didn't tell them in the church, what was going on in our lives, but I was going there taking my children. But would never come with me, because he said, I didn't want to go to church, I want to serve the Lord in the family,

blah, blah. And so my mother and I were taking the children to church, and they had a little school as part of that church. So we decided to put the kids in school. And we did it. My mom and I, we, we put all my children, my school age, children in school,

It felt so good. And we have photos of all my kids in the school uniforms. And they're so happy to be here. That was wonderful. And, yeah, my mother really helped us a lot. And after that stopped trying to take the kids, he resigned himself. And, you know, another thing that happened was during the time when he was really putting the pressure on me to leave to go back to the cult, you know, we'd arguable day and then at night, he put the hard word on the parsecs be like, This is crazy, you know, you expect so much for me. And then it

occurred to me one night, ah, if I were pregnant, he he'd stay, he'd have to stay. So I did my last child was conceived in with my efforts to, to have in stay with us. And yeah, she actually was the glue that kept us together as a family. So out of all of this, I became pregnant and I was having a baby and yeah, and she and so he stayed, he did stay, he did stay. And he got a job selling insurance. He became quite happy going to this church. He liked it. I ended up having a crisis with this church, because they're very similar to the cult and they had a very hierarchical structure, though patriarchal. So even though I was the one who started as going to this church, I was the one that ended up having problems with it.

And she brought him to me, because he turned up at her house, he knew where she lived. He'd been out of the family, maybe two weeks, and he was very agitated and upset, and crying. And she didn't know what to do with him. So she brought him to me. And as we sat at the table, I knew him. Well. I've known him for years and years, I knew his wife, I knew his kids, I loved his family. And, you know, he's crying. And I was so angry. I'm like, they did this to me. They did this to me, when I wanted to leave, they made my life hell. And they tried to keep my kids. And I said, they done it to me, I won't let them do it to you. Famous last words, I should never have gotten involved. Because that, yeah, that is what?

But you did open our eyes to a lot of what was going on. And you made it I mean, because that's the reason why they've been getting away with what they've been getting away with for so long was because nobody knew. And now everybody was aware. And now, they had no excuse for what they were doing. So I know it's hard. But I really think that you made a difference, a good difference, even though you did struggle with it. And you know, you can tell us about that. If you you know, obviously, that's something that we want to hear too. But I I really wanted to say that to you the other day two is that you know, I mean, you are not to blame. You are just as much a victim as we were. And so go ahead, sorry.

They moved into another house, it was called the mount Waverley house. And had given me that number, so I could bring there rather than the regular cold house anyway, I knew the number. Just say that I knew that number. So I rang that number. And it was to give the clothes like I got all these clothes. You know, I'd like to give it to you guys. My kids don't need them. And the woman who answered was the wife of Daniel. Her name was Rachel. And she said, No, no, we don't want your clothes. And I'm like, she was really mean to me anyway. Just put it that way. You know, she's just like, not really want to do.

And we went and same with you know, look, he just wants to find his wife and children. That's all he wants, you know, he just wants to talk to her.
