AFFILIATE TERMS

Approved affiliates of Radical Recovery of Self are eligible to receive commissions as outlined below.

- Standard affiliate commission is 20% of sales.
- If an additional sales call is required, commission may be split (e.g., 10% affiliate / 10% closer).
- Commissions are paid only when the client uses your affiliate link or lists your name on their onboarding form. Screenshots or messages are not accepted as proof.
- Commissions are paid after the 30-day rescind period, typically on the 1st of the following month.
- Payment schedule matches the client's payment method (lump sum or installments).
- Affiliates must remain in good standing with Radical Recovery of Self. Unethical conduct or unpaid membership dues may result in forfeiture of commissions.
