

## Early Life -> Recruitment

Edwin Hamilton was born in 19[REDACTED] to currently unknown parents. He is one of three brothers (see page 5 for more information); they were separated soon after birth. Hamilton grew up in [REDACTED], United Kingdom, with adopted parents. He attended public school through Primary and Secondary Education, receiving above-average grades. After finishing secondary school, he moved on to study law at university. Once he completed his degree, he was hired at a law firm known as E&P Law. In 19[REDACTED], E&P Law started a partnership with the SCP Foundation, allowing a select number of lawyers to represent personnel in the Foundation Tribunal system. During his time within the Foundation, he met RAISA Director [REDACTED] while representing him in a tribunal. This began a form of friendship between the director and Hamilton. After Hamilton showed interest in joining the Foundation, the Director offered him a job as a RAISA operative working within the archival division.

## Incident GC-Yellow-#32045

On the 6/4/19 [REDACTED] within Site-37 Northern Ontario, Canada Global Occult Coalition Lance Corporal "Ferret" had infiltrated the site. Nothing other than the rank and codename of this operative is known at the current date. During the mission, the GOC operative accidentally leaked a virus-like cognitohazard into the site's database. Over 83 personnel were affected by the leak. Cognitohazard #32045 is a Gamma-Class cognitohazard causing "severely incapacitating or painful sensations, beliefs, or experiences in some or all of those exposed" This cognitohazard in particular after visual exposure to the hazard warps and distorts the brain's ability to recognise human faces. This can cause great distress to the victim.

Hamilton was one of the personnel affected by the hazard and badly so. He was submitted to Site-37's medical centre. The following is the evaluation of Hamilton after the incident.

Profession: Consaltoant

Patient: Edwin Hamilton

Type of injury: exposure to a cognitohazard

After the patient was submitted an evaluation was immediately run. The patient showed an impairment in their inferior temporal cortex. This significantly affected their ability to recognise faces. Standard treatment was ineffective and ECT yielded a similar result. I recommend class E amnestics to attempt to trick the brain into "forgetting the hazard".

Hamilton is one of three known brothers the following page will give information on both.

### Edvin Hamilton

Edvin Hamilton after being separated experienced a very different upbringing from Edwin. He grew up in the country of [REDACTED] which at the time was in a civil war. At a young age, Edvin joined the military after showing good competency within the military. Edvin was scouted by local forces of the Chaos Insurgency after successfully being initiated he was transferred to the CI cell located in Pinewood, Canada. During a raid on Site-65, he was declared M.I.A and no corpse was ever found.

All information in this section was gathered from an intelligence operation within CI Cell-PC-202 taking documents holding reports.

### "Alexander"

During extreme tensions between the Foundation and Global Oocult Coalition, a massive raid was conducted on the local Nexus data centre a hard drive containing many personal files was found one of which being another brother of Edwin.


