## Timings

Our Klaviyo email flow management service timeline is an ongoing monthly service.

## Investment

## Terms

### Payment terms

- For projects under \$5K, we charge 100% upfront.
- For projects between \$5K and \$15K, our policy is to charge the higher value between \$5K or 50% as an upfront deposit in order to secure the work on our schedule. The second/final invoice for the remaining balance is scheduled to be paid half-way through the planned project duration.
- For projects exceeding \$15K, our policy is to charge a 40% deposit upfront in order to secure the work with the 60% balance being split into two equal payments one-third and two-thirds of the way through the planned project duration.
