First of all, congrats on the trophies! You guys survived far more thirty days on the island and beat out 16 competitors to be sitting where you are right now. That's an achievement!

My vote is open. I ended up bringing up a lot of questions (~there are technically 10 for each of you) so if you overwhelmed, you can pick and choose. A few of these questions are meant to be helpful to other jurors and game viewers, while the last three"questions" on the doc are all meant to be helpful to you!

I don't mind if you decide to "pass" a question (the last two in particular), but I would appreciate it if you take the time to answer them all and not to dodge them if you do decide to answer them.

I will address issues that I have in both jury speech's individually; and then fire a bunch of a more generic questions at the end.

# <u>For Voice</u> HEY SAM ILL ANSWER THIS SHT WHEN IM NOT DEAD INSIDE SO DONT VOTE YET THANK U

Grats Voice on the trophy! You made it! I will start by talking about issues that need clarifying in your jury speech.

One of the first things you say is that you "blamed Anthony with the creation of the Angsana/Sarawak alliance and relinquished all credit for it". Merge may have been a long time ago; but I have no recollection of this event (blaming Anthony for the creation of Angsana/Sarawak alliance and you having no culpability) ever happening. Why might I not recollect this other than bad memory? Would you consider casting them as backstabbers a big part of your game?

Hi Sam! I think what I was trying to for there was that I was trying to paint members on Sarawak as playing both sides so that people on Mari Mari would be more willing to not vote anyone on Angsana for the first few votes at least. It was more or less a tool to solidify safety and place myself in a good position by doing what I said Sarawak was trying to do (play the middle). I feel like it's not an exaggeration to say even after alex was the first merge boot and was on Mari Mari, the people on Mari Mari were more willing to vote for the people on Sarawak than they were for Angsana. I think painting some of them as untrustworthy helped me significantly in establishing my relationship with Sonia because I'd been saying all this shit and then didn't vote her when everyone else on Sarawak did, but I think it also kept the votes off of Angsana for the first few votes until Anthony used his power, and if Anthony didn't use his hidden immunity, I think he would have gone home then instead of anyone from Angsana, so I think it was a pretty good chunk of my early-merge game. The reason why you may not have known anything was because I found strategizing with you to be kinda

taxing because you tended not to give out very much information in return, so I didn't see a need in strategizing with you if you weren't trusting of me. Here's a few examples of stuff I said:

The next statement that doesn't match up with my own reality is the idea that "the belief that Sarawak was backstabbing pervaded into the deeper parts of merge where Mari Mari eliminated tillie/N1ed/Anthony almost in a row."

Tillie was an opportunistic Mari Mari vote that I thought occured because Angsana had thought tillie was backstabbing them and Mari Mari would've jumped at any opportunity to not vote one of their own out.

The next vote out was ponds - which involved communications with N1ed and Anthony, both Sarawak, and poor ponds had hardly done any backstabbing for her time in the merge!

I believe that the n1ed and anthony votes both occurred because you were protected by Claire and Amelio was protected by Nadine rather than by any distrust towards them. I had personally considered an alliance with anthony/bryce/me/nadine in order to knock you out at f7. I may have been an outlier among the mari mari.

That is my perspective on that. Could you clarify whether or not casting the Sarawak as "backstabbers" played a role in their wipeout, and specify any votes where it impacted who was heading out?

With all due respect, what you were considering clearly didn't line up with what actually happened. I didn't go out at final 7, and there were definitely reasons why Sarawak was wiped out before Angsana was. Sarawak's wipeout obviously is a lot more complicated than just casting Sarawak as playing the middle, but that's what made getting votes on Sarawak especially easy, because you could just say "oh they were playing the middle of the game ofc they're untrustworthy". The drive to set Sarawak up as backstabbers was more of an early-game play that kinda got bodied when at one point in the game (f9) all Sarawak players became immune, but I think if Anthony wasn't immune at f9, he would've gone home, so your alliance of bryce/anthony/nadine/you wouldn't have existed anyway. It's hard to say "oh this is the only reason \_\_\_\_ went out" because there's a lot of reasons when it comes to voting someone out, it's never just one reason. So while I can't be like, yeah this the only reason someone was voted out, but I believe it was at least one of the reasons as to why every member on Sarawak was voted out before f6. There's a pretty big difference between "playing a role" and being the only reasoning behind targeting someone. I know that this wasn't the only thing that kept me relatively safe in early merge, but I think it was important aspect that did keep me safe. You can read the logs above and see what I'm talking about.

Just kidding, I only have one more thing I need elaboration on regarding your jury speech.

"The supposed Bryce/Anthony f2 rumors propagated by members of Mari Mari continued to keep the target off of my back"

I never seriously believed them and did not spread them except rather sarcastically, and I doubt Bryce spread them himself. Who specifically was spreading these rumors, and who specifically do you think believed them (name them)? Do you think it ever played a role in determining a vote, and if so, whose and how? I know I spread it a good bit, and I heard it originally from both Sonia at merge, but I'm pretty sure I had heard it in premerge somehow too, but I can't find the logs from who told me. Congrats for not taking it seriously, but I think anyone that wasn't anthony/bryce saw it as a potential option for the first part of the merge (first couple of votes), which was really the only point of spreading it in the first

place. I don't think it lead to any votes, but it stayed on people's minds (other than your godlike self apparently) and gave additional reasons why Sarawak maybe shouldn't be trusted. When the f4 of you/tillie/bryce/anthony leaked too, that also fueled logic supporting that their f2 could exist, so whether anyone believed or not kinda doesn't matter, it just adds an additional reason not to trust Sarawak and maybe a reason to focus on people that weren't me (anthony/bryce). You can see the example of where I leaked it above (I bolded it.)

I have five question strings for Bryce, and three for you, so I will carry on and ask you out-of-context:

What were you plans for f4? At any point, were you seriously considering taking me, or were you already locked and loaded with your double f2?

No I wanted you out for a long time to be perfectly honest. The double f2 actually covered my bases pretty well into f3, so I only tried to talk to you about votes to leak anything that you said that was questionable to both bryce and amelio, since I knew the best thing for your game would be trying to do what I was doing to you (taking out someone that would be taken to the end by amelio/bryce).

Please elaborate on the relationship you had with Claire in this game. This question has significant overlap with Claire's regarding why she should vote for you when she constantly seemed to save you; but it is a bit more broadly focused.

She covered for me in Mari Mari while I covered for her on Sarawak/Angsana. It was a mutually beneficial relationship, and the only reason that it seemed like she was doing me more favors than I was doing her was because y'all had the majority the whole time. If you look at all the votes post ponds getting out, every single person on Mari Mari was voted for the next 3 votes except for Sonia, and that was pretty much my doing. I said to everyone remaining that I wasn't voting for Sonia, or gave reasons to not vote for her, and they couldn't even attempt to vote her without my vote.

I kinda don't really get the logic in someone not voting for me because Claire seemed to save me when bryce was covered by Mari Mari, didn't throw out any votes or do anything but sheep Mari Mari until then, and then never tried to flip against them when he knew he was probably in the bottom, but I'll get to that later. If you're comparing mine and Bryce's games, I know I was a LOT more autonomous than he was at any given moment, so that shouldn't really even be an issue, in my opinion.

## For Bryce:

Hi Bryce! Congrats on getting to f2!

The biggest issue I have with your jury speech is when you talk about f6. Up to that point and even beyond that point I agree with most of what you say.

I raise an eyebrow where you say "I was able to guarantee each member would be safe" despite that achievement involving multiple people, such as Nadine winning immunity, and I solving the idol clue, along with the whole tribe spreading their guesses out for rice in order to win the reward challenge for advantages. The additional clue we also gained from the island was even rather redundant, because it revealed something Claire had already inferred (Periodic Table). Could you clarify how or correct your statement that you had the largest role in securing immunity for % of our tribe?

First off, love the font!! If your question is asking whether I was intending to take full credit for the Mari Mari play then the answer is no. I cannot answer the original question because I did not intend for y'all to take it as me claiming credit for the idea as a whole. What I originally meant was that the "I" meant that apart from Tucker, I was involved in a game changing plan to ultimately put Mari Mari as the leading tribe for the rest of the game. It is my fault that I chose such an ambiguous approach to the topic, but I knew that I had to mention it because it was something that Tucker was not a part of. I'll correct myself now and give credit to my fellow Mari Mari tribes for making a great tribe play, and if you ask what I think I contributed to the play, I'll say that by outting my idol I allowed for there to be more trust within the tribe allowing for the play to commence smoothly.

I also believe your role as a persuader to be overstated in f6, because Claire had voted for you almost immediately after the revote was announced. It's still fair to say that your goodwill influenced Nadine and I's decision because we thought you would stick with us as a vote; at the same time we voted because of the perceived Claire/Tucker connection and the threat they posed rather than anything you said (which was very little). Saying that you knew you had to "make it" go 3-3 is a stretch here because I know you were unaware of the vote on you prior to my mention of it. I also know that Nadine was considering you on the revote until I got worked up and made a case about Tucker/Claire to her with no involvement from you. In what active role, if any did you play in the vote? Is my perception of that vote flawed? I don't have an issue if your role is "minimal"; but I am just bringing this up in case another juror would like to know what was going on.

After the revote was announced I began to ponder the different situations that would ultimately take place. I figured that my loyalty to you and Nadine would play a major factor in y'all not voting for me, but I couldn't really see a situation where Nadine would flip because she had immunity. I was very lost at this moment (which is an answer to another question), but I did know that Claire had become unpredictable which would hopefully convince you and Nadine that it was in your best interest to go for rocks, but I felt that I had very little control over the situation and felt very uncomfortable with how exposed I was. So, I'll say that from my point of view when considering your perception, I thought that you and Nadine had a strong pact, and voting me would cause you two to end up in a worse situation because you would be the minority in five. I thought that the bonds I made with both you and Nadine, and the benefit of keeping me if you thought I was a loyal number, would allow you both to not flip.

I would also like to know at f5, where would you rank people as jury threats? Please do not place people in ties, and include yourself! If you place voice as a low jury threat, I would like you to elaborate on that in detail. This would help clarify your endgame play.

threat? Stating how your game is strong is not an answer I am looking for here - it's true that it could be, but if that's the case, you could have taken people other than voice. I am looking for reasons why that it was not a "monumental feat" for voice to survive to f2 despite being in minority and targeted probably more frequently than any other player in the game.

Tucker usually had to try and convince others to stay in the game, and when people usually went with tucker, they did so because it benefited them in the long run. Also, Agus

and Tucker were always on the chopping block at f6, and never really could control their fate. Claire attempted to keep both of them in at f6, but it didn't work (It was a 50% chance that it would have worked out though). Then they lucked out because my most favorable road allowed for them to stay in for a bit more. I could of stayed with Nadine and you, but I knew that I was likely to get third because Nadine was a challenge threat and would take you to F2. If I tried to tie it up at f4 there's no guarantee that it might just come back to bite me and I'll end up getting fourth. So I decided that my best gameplan was to flip on my original alliance so that I had a chance to trophy past 3rd. I believe that Tucker got carried to the end of the game by me, and while he might have had a few jury votes that I thought I wouldn't be able to get, I believe that the jury will ultimately vote for me to win.

At the end of your speech, I am curious about this statement:

"I often made sure that I would seem like I didn't have the best grasp of the game so that they would not suspect me of ever flipping or trying to play my own game"

The latter part is true! But I need clarification about the former part. When, if any times, did you think you had a "good grasp of the game?" when you acted otherwise? When, if any times, did you feel at least a little bit lost?

If your answer starts to shape up to something like "I'm never certain what happens in a survivor game so I was nervous all the time!" then please talk about when you were relatively certain about where the game was going and when you were relatively lost. When Alex was voted out at F11 I was not expecting that. I truly believed that the Angsana members were going to vote Tara along with me, you, Nadine, and Claire. I also would say I felt lost at the F6 vote when it initially happened because I had thought that Claire could flip on me but I guess I was trying to will her with my thoughts to not flip lol. Times were I was playing up the fact that I didn't know what was going on could include the F7 vote for Anthony. I tried to pretend like the reason I didn't want to go through with the plan to vote Tucker instead and not tell Claire was that it would be mean to exclude her, but really I was thinking strategically that the plan would easily blow up in our faces. I also believe that when the

rumors were spread around me having an idol or being F2 with Anthony, I played it as if I was naive. Even though I knew that the rumors most likely came from Claire, my own alliance member, I pretended to not know who would come up with them to my alliance, and then when confronted by people not in my alliance with accusations at Claire, I would simply feign that I didn't care that she was doing it. I believe most interactions I had with people left them thinking that I was depending on them for help in the game and for them to carry me, but it was just a charade so that I wouldn't be seen as someone to watch out for.

"I'm super glad to be able to be here"

I have little issue with that! Grats on your trophy no matter how the votes go!

## **QUESTIONS FOR BOTH OF YOU**

At f5, Voice, you say you flipped Bryce to vote Nadine and I out.

At f5, Bryce, you say you would've flipped on us regardless of outside persuasion.

At this tribal and the f4 tribal, who convinced Bryce to flip? (Was it you, Voice? Or was it your own logic, Bryce?) and what evidence do you have to support this? If you break out logs for support, that would be solid. The more specific examples you give, the better.

If it was your sole action, Bryce, then the narrative goes that you flipped at the right time and carried Voice to the end.

If it was you, Voice, who flipped Bryce, then you recovered from being the minority from the entire game and almost single-handedly wiped out the Mari Mari tribe.

I believe that this is an important question! If you do not think this is important, then please explain to me why.

I agree that this is an extremely important question because it's one of the reason why I think I should be voted over Tucker. I had analyzed the situation in f5 and had decided that I had a choice. Be complacent like I had been pretending to be in the past and get a bronze trophy, or flip and be in a situation where I was still getting bronze at least, but had a great chance at silver and gold because of the eliminated challenge threat Nadine and I was next in line challenge threat wise. I had always had the plan to flip at F5 because going to F3 with my you and Nadine was never going to work for me. I was not just convinced and flipped by Tucker at F5. He had tried to flip me at many tribals before and I had refused because it wasn't good for my game, the reason I flipped was due to my own actions and reasonings which I believe were logical and valid in this situation. In the end I knew what I wanted to do, and had to drag Tucker with me because I needed a number and someone I could beat.


Thanks for asking these questions!!
