- 2:40-2:55--[TDE](#) Addendum update and language approval **Approved**
- 2:55-3--ESLA 3180A and 3180B, which were just approved on 9/23, were re-**approved as 3165 and 3175**, respectively, because the former courses numbers exceeded the 4-character limit.
- 3-3:10--ESL 75/85/95 [advisories](#): expedited changes **Approved**

- 3:30-3:50--The place of "participation" in the outline: The CC has been enforcing the inclusion of a participation line in every outline's evaluation section. That guideline is suggested in the outline crib notes but is not not an explicit policy in the handbook. The discussion focused on whether or not that standard is always necessary. Despite the idea of participation being universally embraced, it may not always be an accurate category in the context of evaluation. In some cases performance might be a more accurate category to capture participation than "participation." While "active participation" should be promoted in outlines and will be looked for by reviewers, and in most cases will appear under "participation," such involvement or engagement in a course can also be evaluated without the categorical label of "participation" appearing in the evaluation section.
- 3:50-4:10--Minimum number of units for [GE courses](#): This was an informal discussion on whether or not the inclusion of .5-unit GE courses may be creating confusion for students or hindering their completion of GE requirements. The formatting of the current GE worksheet does not distinguish clearly enough which courses taken alone do not satisfy a GE area. A more student-facing design is needed, regardless of the good work that counselors do to help students with their GE choices and educational plans. There are also CSU articulation issues with such courses. Further discussions will be needed with departments on how to present these distinctions and on the criteria for .5- and 1-unit courses in, say, GE areas requiring 3 units.
