

- The Buyer name, address, email, and user names are stored solely on your phone and will be deleted 35 days after the order has been placed or 14 days after the order is completed, whichever is sooner.
- The developer does not collect or have access to buyer names, user names, addresses, email addresses or any personal information that may identify you, your store, or your buyers.
 - Debug Log files: If you send your log files to the developer by email. The
 developer may see developer names, addresses, purchased parts, prices. These
 are used by the developer to fix bugs and are not stored or used for any other
 purposes.
 - If the feature is activated to 'Share Qty on Cloud', the only information stored is date ordered (YYMMDD), order_id, inventory_id, and quantity picked. This data is used to share picking progress across multiple devices.
 - Subscription holders will be identified by their store name in the cloud. All
 passwords are stored in a secure and encrypted database and retrieved with a
 hash. Generic inventory data (inventory ids, quantity, description, price) your
 store name, order number, order status, and date are the only information stored
 in the cloud.
