- 3. UNFINISHED BUSINESS.

A. GC MEETING TIME.

- a. Agreed to move this meeting ahead 1 hour to 10am ET (Dagmar asked Scott to change the time on the calendar). **Unanimous**
- Agreed to put out a WhatsApp poll to determine if another time would be better for members (Pamela will generate a poll). **Unanimous**

- B. **CURRENT VACANCIES. IDENTIFY. VOTE ON NEW LEADERS.** See onboarding protocol below.
 - a. Martin was considered for and appointed to leadership of the Saturday meeting.

 Unanimous.
 - b. Tim requested and was appointed to lead the Friday meeting. **Unanimous**. Tim noted he may be absent occasionally due to other scheduling demands and would need a substitute for those times.
 - c. Carol-Ann was recognized as the leader of the Sunday meeting.
 - d. Review of current openings. This is the status of openings as of today. Pamela agreed to post a notice in WhatsApp to alert members to the current situation and request service to fill the gaps.

- **4. ONGOING MEETINGS.** What do we do about leaderless meetings?
 - A. Meditation meetings on the calendar without a leader for 3 weeks will be taken off the schedule until such time a leader steps up, then it will be put back on the calendar.
 Unanimous. Note: This protocol is adapted from the EGGA protocols for handling leaderless meetings. Pamela will post this in the WhatsApp.

5. Other Leadership Questions.

- **A.** Protocol regarding leaders of potential leaders struggling with sobriety. The discussion focused on "potential leaders." Agreed to keep this on a case by case basis with the requirement that the individual has to meet with the GC to be considered for appointment. In support of that, it was agreed to change the language of the current protocol to be more specific about how this situation is handled. **Unanimous**.
 - Only the Group Conscience can vote to appoint meeting leaders who do not strictly adhere to the minimum leadership requirement on a case by case basis. An individual interested in leading must attend a Meditation Group Conscience to be considered for meeting leadership.
- **B.** It was agreed to *clarify language for appointing a temporary leader by a trusted leader,* by adding the following language related to leadership requirements. Unanimous.

- At the sole discretion of one trusted leader a temporary appointment of a meeting leader can be made for an opening on the calendar if that individual meets the minimum leadership requirements (30 days sobriety, attended 10 meetings). The temporary leader is expected to attend the next Group Conscience Meeting to be formally appointed.
