



Senator thank you note how to:

1. **Find your Legislators!** Use this link: [District Finder](#)
2. **Get their address.** Click on your Senator and Representatives' name to find their Olympia office addresses. If you're writing this later than 4/14, it'll be better to email them.
3. **Check if they voted yes.** I have screenshots of the vote roll call below for each bill. If they didn't vote yes, you can still write them a note, or you can thank Rep. [Bateman](#) (HB1110) and Rep. [Duerr](#) (HB1181) for their leadership on the bills.
4. **Write your thank you!** If they voted yes on any bills, write a thank you and urge them to get the bills over the finish line. If they didn't vote yes, still urge them to get it over the finish line.
5. **Stamp it and drop it in the mail!**
6. **Track.** On the last page of this sheet, there's a place to type your name and the legislators you sent a thank-you to.

Context for postcard:

1. What are we writing about?

- a. Passing HB1181 and HB1110 out of the legislature! Our legislators only have until April 23rd to pass our bills. They've both passed the House and the Senate, but they need to agree on amendments before they're fully passed.
- b. Here's more on the bills:
 - i. **HB1110– Middle housing** – This would add more housing options into all neighborhoods statewide. It would bring an end to exclusionary zoning by allowing duplexes in all areas zoned for detached single family residences and fourplexes in other areas.
 - ii. **HB1181– GMA Climate** – This legislation requires that the largest and fastest growing counties and cities within them to reduce greenhouse gas emissions and vehicle miles traveled through land use planning. It also requires all jurisdictions to plan for resiliency and address the impacts of climate change.

2. So what should I say?

- a. We're thanking them for voting yes (if they did), and urging them to get the bills over the finish line before the clock runs out. They only have until April 23rd to get these bills out.

3. Why postcards anyways?

- a. Postcards are a great way to demonstrate the personal support for these bills. Our legislators are hearing a lot from special interests, so reminding them what their constituents care about is very impactful.
- b. And having something that is physical is even more memorable!

4. Why now?

- a. We've only got until April 23 to pass these bills!
