SERVICE PROVIDER/TEMPORARY EMPLOYEE

SERVICE PROVIDER TEMPORARY EMPLOYMENT AGREEMENT

This Agreement is made between _____ Orleans Central Supervisory Union _____ School District, hereinafter referenced as School District and _____, Service Provider/Temporary Employee, hereinafter referenced as Service Provider/Temporary Employee.

In consideration of the promises and mutual covenants and Agreements contained herein, the parties agree as follows:

Work to Be Performed

The School District needs the Service Provider/Temporary Employee to perform, and the Service Provider/Temporary Employee agrees to perform, the following work:

- OCSU Ed Camp- Teachers participating in this professional learning opportunity will:
- Participate in small group workshops, forums, whole group sessions, mini sessions, flexible work time that are focused on Proficiency Based Learning and Elements of Effective Instruction
 - Create professional goals for the week and provide reflections towards achievement of those goals using an online platform
 - Provide feedback to colleagues to support their work towards the achievement of teacher or team goals

Terms of Payment

The School District shall pay the Service Provider/Temporary Employee pursuant to the School District's payroll procedures. The Service Provider/Temporary Employee agrees to submit timesheets as outlined by those procedures. Payment will be made to the following terms and conditions:

The Service Provider/Temporary Employee's rate for teachers will be ____\$25.00____ per/hr. and paraprofessional's will be paid their per diem rate. _____.

Benefits

As a Service Provider/Temporary Employee, the Service Provider/Temporary Employee will not be entitled to additional compensation and benefits unless required by state or federal law. The School District shall cover the Service Provider/Temporary Employee under the provisions of their worker's compensation and liability policies as required by law and pursuant to the carrier's terms and conditions.

Term of Agreement

The services called for under the Agreement shall commence on **June 18th, 2018** and terminate on **June 22nd, 2018**. The employment relationship will end upon termination and the school district has no obligation to offer future employment to the Service Provider/Temporary Employee.

Termination

The School District may terminate this Agreement at any time if, in the District's sole determination the Service Provider/Temporary Employee fails to fulfill the obligations under this Agreement. Such determination shall become effective as determined by the District.

Background Checks

The Service Provider/Temporary Employee, in the delivery of services **WILL NOT** have unsupervised contact with school children. If they are intended to have unsupervised contact with school children they are required by law to go through a Criminal Record Check process at their expense prior to engaging in services to the district. The School District will assist the Service Provider/Temporary Employee in completion of the process, but will not provide reimbursement for the expenses of either fingerprinting required or the Criminal Record Check itself.

Confidential Matters and Proprietary Information

The Service Provider/Temporary Employee understands and agrees that in the course of his/her working relationship with the School District with he or she may receive and become aware of student, employee and school district information, projects, practices, contractor information, relating to School District business. The Service Provider/Temporary Employee hereby acknowledges the sensitivity and confidential nature of such information, and covenants and agrees to keep all such information strictly confidential. In this regard, the Service Provider/Temporary Employee shall not at any time or in any manner, either directly or indirectly, divulge, disclose, communicate, or use the information he or she obtains or is otherwise exposed to as a result of his or her working relationship with the School District.

Choice of Law

Any dispute under this Agreement, or related to this Agreement, shall be decided in accordance with the law of the state of Vermont.

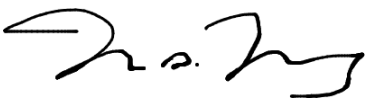
Agreement

This Agreement supersedes all prior oral or written Agreements, if any, between the parties and constitutes the entire Agreement between the parties. The Agreement cannot be changed or modified

orally. This Agreement may only be supplemented, amended, or revised in writing by the Agreement of the parties.

Partial Invalidity

If any portion of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions shall nevertheless continue in full force without being impaired or invalidated in any way.
