## Introduction

Labour is pledging to reform public services with tech. But who should they listen to on how to do it?

One specific proposal is that we should introduce concurrency for regulators on equalities obligations, similar to the way we do on competition law. This would mean regulators like the FCA and others would have an explicit mandated to stop discriminatory uses of technologies e.g. in finance. At the moment they leave the space to the EHRC which is ill-equipped to get into these complex questions within sectors.

Spinning the wheels on those things isn't helping the already incredibly low levels of public trust that exist in the UK (for all sorts of obvious reasons unconnected from anything to do with tech).
