Course Description: Students will participate in their second of two level II fieldwork experiences which are required for the program. An in-depth experience in the delivery of occupational therapy services will be provided in one of a variety of clinical placement sites. This experience shall further develop and expand students' repertoire in order to develop competent, entry-level prepared occupational therapy assistants that are skilled in applying the OT process to client care. Students will be mentored through this experience by a qualified OT Practitioner. In addition, students will participate in an online component to the course which will challenge students to identify and discuss trends and issues facing the profession in a variety of service contexts. Service delivery concepts will be explored with topical areas to include, but not limited to, management concepts, reimbursement, quality improvement, supervision, and leadership.

\*Students must pass both clinical and online components of the course in order to pass the class.

NOTE: According to the Accreditation Council for Occupational Therapy Education (ACOTE) standards for an Occupational Therapy Assistant program (C.1.10), fieldwork II may be completed on a part-time basis as defined by the fieldwork placement in accordance with the fieldwork placement's usual and customary personnel policies as long as it is at least 50% of a full-time equivalent at that site. Level II fieldwork must be completed within 12 months of academic preparation.

**Prerequisite:** Successful completion of all OTA courses

#### **Textbook/Required Materials**

No new texts to purchase for this course but all of your texts are resources that should be used while on FWII.

#### **Outside Resources**

- In addition to the required textbooks, we will be using Youtube videos, films, online articles from sources such as AOTA, and scholarly articles.
- However, instructors are not the only ones responsible for resources in this course. You will be assigned tasks that will require you to locate and share evidence-based resources.

## **Relationship to the Curriculum Design**

#### **Curricular Threads**

Professionalism is expected and assessed in this course on the JCC OTA Fieldwork II Evaluation of Student Performance (FWESP) form. Students participate in various project based activities, as directed and monitored by the AFWC, in an effort to make a portion of student learning consistent, as well as to ensure alignment with the didactic portion of the curriculum. All projects are related to topics taught in the classroom, but they challenge the students to generalize their knowledge and apply the skills during real life experiences. Additionally, they must create and explain treatment interventions based upon occupational based interventions demonstrating client-centered care. Reflective Practice is expected and refined throughout this fieldwork experience.

# **Scope and Sequence**

In this fourth semester course, students are expected to demonstrate increased depth and comfort with application of their knowledge. This fourth semester course has 2 components: a clinical aspect and an online/didactic aspect. Students take this course upon successful completion of OTA 2700: Fieldwork IIA

#### **Related Theories**

Fieldwork II occurs in the final semester of the program, once all other coursework has been completed. In order to be successful on fieldwork II, they must possess all the qualities of a self-directed learner. All levels of thinking and learning, as outlined by Bloom's Taxonomy will be employed in this course. Clinical reasoning skills are expected and assessed in the projects for the online portion of the course.
