Abstract

Abstract should be written in English. It consists of maximum 200 words in a single paragraph only. Do not put any citation in the abstract. We encourage you to write the background of the research, the purpose, the brief method, and the results. Substantially, the abstract should attract the potential reader to read more.

Keywords: select minimum three, and maximum five keywords, which best describing, your article, write in alphabetical order

INTRODUCTION

This template aims to guide you to prepare your article for submission to IJEI (Hartanto, 2019). The size is A4, with margins on the left, top, right, and bottom respectively are 3 cm, 3 cm, 3 cm, and 3 cm. The article needs to be minimum 5 pages in length, and maximum 20 pages. It uses a single space and one column format and written in Bookman Old Style font style with size of 11.5 (Istihapsari & Istihapsari, 2019).

The title of an article should consist of the fewest number of words possible that accurately describe the content of the article, maximum 13 words is OK. It is written sentence case, which means only the first letter of the first word is capitalized and the rests are not.

Authors name should be written in full. We strongly encourage a collaboration project, not a single author project. However, a single-author article may be considered for publication if it is substantially excellent. Put a superscript number to each author referring to the affiliation, and put a star symbol to indicate the corresponding author. Then, write the affiliation, its address, city/province/state, and country. The corresponding email is also needed.

In the introduction section, author needs to present the research gap, the research questions, and the research goals. Furthermore, by doing extensive review towards an adequate number of studies, author needs to claim the novelty of the topic discussed in the article, and what the contribution of the article to the existing topic is.

We encourage authors to integrate the introduction and literature review to make the ideas more comprehensive.

RESEARCH METHOD

We welcome any kinds of research methodology, i.e. qualitative, quantitative, mixed-method, design research, and also R&D. In this section, author needs to explain the kind of research, the research procedure chronologically, the design, the participants/population, the collection data procedure, the instruments, and the data analysis technique.

In a simple explanation, a good method is when the reader could adapt what is going on the research into their setting.

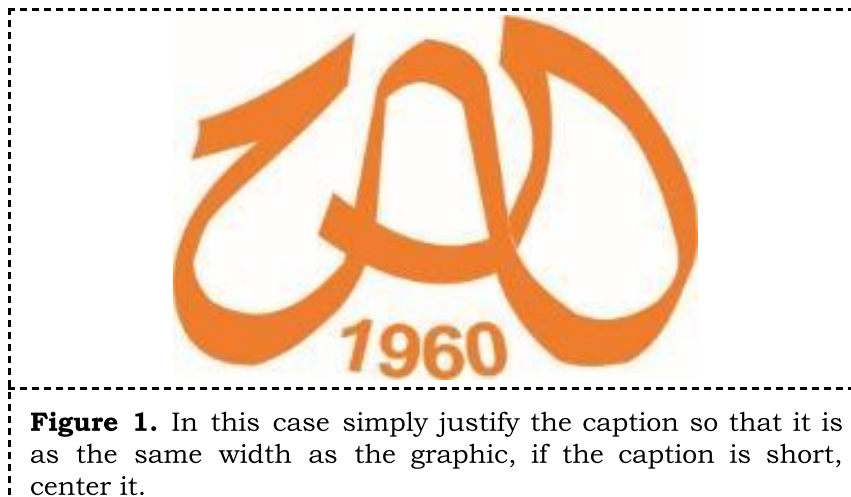
RESULTS AND DISCUSSION

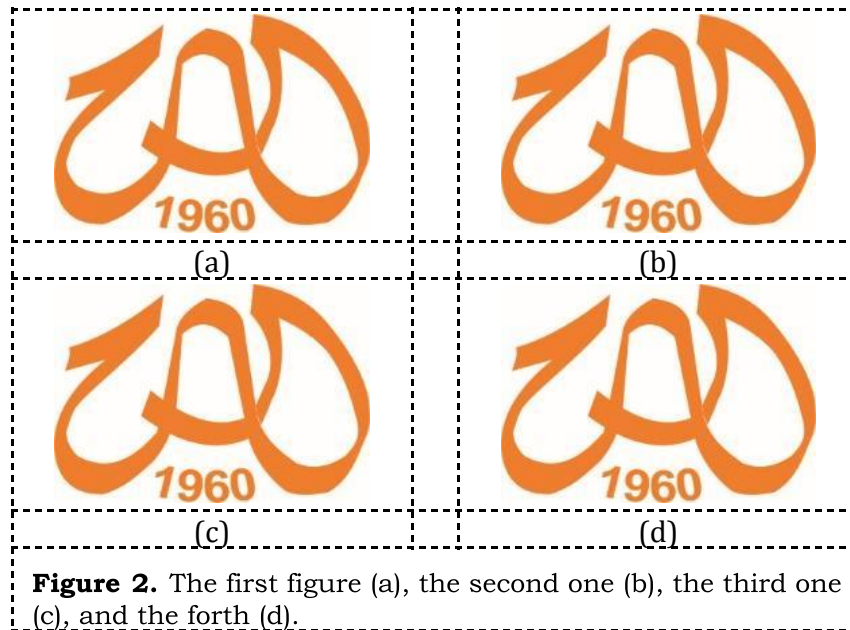

If author needs another sub-subsection, it can be written in italic sentence case. Moreover, we encourage author to present figures and tables. Tables and figures are presented centered, as shown in Figure 1 and cited in the manuscript. The dotted line is only a guidance to put the figure on the correct position. After it is in a good fit, make it borderless.



Furthermore, if a set of figures consists of some other figures, you can make it as presented in Figure 2. Please make sure that the figures are presented in a whole form, not separated into different pages. This suggestion also applied for table presentation. Authors are encouraged to present the table in a whole, not separated into pages. Therefore, instead of presenting a long table, authors could consider dividing or distributing the content of the long table into some tables.

Author should also avoid a blank space like this. If a blank space is accidentally created because of a figure or a table moved into the next page, then the author could switch the paragraph to fill the blank space.



For table, it needs to be put center, and only has three horizontal lines. It is illustrated in Table 1.
