<u>Dwelling Type.</u> Sheds shall be allowed based on standards and stipulations set by the Board.

(This requires a vote of 75% of all owners of the lots to approve or disapprove.)

3. To adopt the following amendment to the Declaration of Covenants, Conditions and Restrictions for Madison's Grant Homeowner's Association, adopted July 27, 2006 (the CCRs)

RESOLVED, that the Members of Madison's Grant Homeowner's Association hereby consent to, approve of, and authorize amending Article IX-General Guidelines Applicable to All Lots, <u>Basketball Hoops</u> of the Declaration of Covenants, Conditions and Restrictions as follows:

<u>Basketball Hoops.</u> Permanent basketball hoops shall be allowed based on standards and stipulations set by the Board.

### Madison's Grant Homeowner's Association Annual Meeting 6:30 PM, July 23, 2013

### Proposed Amendment to Association's Declaration of Covenants, Conditions and Restrictions

The amendments on the agenda for the upcoming annual meeting are being proposed by the Madison's Grant HOA Board of Directors.

The Board of Directors recommends adoption of the proposed amendments.

### **Dwelling Type**

The current version of the Declaration of Covenants, Conditions and Restrictions does not allow for sheds. Association members have expressed interest in building and, in fact, have already built sheds. The Board proposes that sheds be permitted under the following conditions:

- a. Design and placement must be approved by the Board when acting as the Architectural Control Committee or the Architectural Control Committee itself, when established.
- b. Sheds may be no larger than 120 square feet in total dimensions.
- c. Sheds must be of the same materials and color of the siding and roofing of the main dwelling on the lot.
- d. Sheds must meet building requirements established by the City of Kettering, however it must be noted that stricter standards are set by the Declarations than the City and both sets of standards must be met.

### **Basketball Hoops**

The current version of the Declaration of Covenants, Conditions and Restrictions does not allow for permanent basketball hoops. Association members have expressed interest in allowing permanent basketball hoops. The Board proposes that permanent basketball hoops be permitted under the following conditions:

- a. Permanent and portable hoops must be well maintained.
- b. All rules currently pertaining to basketball hoops in Article IX such as lighting, placement and hours of use remain as stated in the Declaration of Covenants, Conditions and Restrictions.
