REPORTS OF PROGRAMS AND COMMITTEES:

Advocacy and Zoning: Councilwoman Murphy asked us to consider support for BL2021-621 which is an ordinance amending Sections 17.40.720 and 17.40.730 of the Metropolitan Code, Zoning and Regulations. This bill requires additional public notice, regarding applications for permits from the Historic Zoning Commission, be sent to all houses within 250 feet of the property.

Motion made to send letter to Council communicating SPNA's support of the bill, including Councilman Allen's proposed amendment. **Motion seconded and passed.**

Beautification:

• Trees: Cherry tree pruning will take place from 1-4, with the Nashville Tree Foundation, on March 20th. If you can help, please meet at McCabe Park, between the golf course parking lot and the recreation center entrance at 1 PM. Karri Suh and Jenny will meet with Jennifer Smith, from Metro, to determine which trees are dead. A planting and sustainability plan will then be developed. All suggestions for where to plant and the type of tree to plant are welcome. There are fund available in the tree bank, we can apply for these funds for planting and watering.

Sylvan Park Mom's Club: Loralyn Greene sent an update regarding the Mom's Club. In February they delivered treats to 5 hospital break rooms. They had a toddler meetup, a baby meetup, a weekend playground meetup, a few families met at the zoo, and they had a talk about self-care. They are planning for the SPMC Easter egg hunt on April 3rd. The Mom's Club has also been active in donating children's clothing, toys, and "equipment" to refugees from Afghanistan.
