# S.E.X-020 "Idol of the Laudable Man"

Item: S.E.X-020

Risk Rating: Hypatia Brigid

# **Protection/Observation protocol:**

S.E.X 020 is to be kept in special item anomalous security safe in proximity to other subjects labeled S.E.X 020 A and S.E.X 020 B, which are to be kept in incognito humanoid holding facility "Evergreen Acres", in a large "harem" scale research house. While S.E.X 020 is to be kept in a standard *Hypatia* class containment safe, S.E.X 020 A and instances of S.E.X 020 B are allowed to roam the property of the house freely. Any *Type B* Males should be kept away from S.E.X 020 and all instances of S.E.X 020 B as they are at high risk of becoming additional instances of S.E.X 020 B, and causing further changes to S.E.X 020 A. S.E.X 020 A is allowed to leave the facility bi weekly, while guarded by SRT scout 14 "Bros



before Hoes," for personal time and possible psychiatric evaluations. Furthermore, S.E.X 020 A has shown great cooperation and understanding towards the S.E.X organization and its goals, and has accordingly been provided level 3 privileges, dependant on continued good behavior. This does not extend to any of the instances of S.E.X 020 B. Children born from Instances of S.E.X 020 B have shown no abnormal abilities or behavior, and are allowed leave and enter the facility for scheduled visits with the cover story that both S.E.X 020 A and S.E.X 020 B instances suffer from various forms of social anxiety issues, and are there of their own free will.

S.E.X-020 is to be kept in special item safe modified with interior observation equipment. The twelve individuals labeled S.E.X-020-A and all instances of S.E.X-020-B connected to them are

to be kept in the residence and research facility "Evergreen Haven," in large "harem" scale observation houses. Instances of S.E.X-020-A and instances of S.E.X-020-B are allowed to roam the property of their houses freely. Any *Type B* Males should be kept away from S.E.X-020 and all instances of S.E.X-020-B as they are at high risk of becoming an additional instance of S.E.X-020-B, and causing further changes to instances of S.E.X-020-A. Instances of S.E.X-020-A are allowed to leave the facility bi-weekly, while guarded by SRT scout-14 "Bros before Hoes," for personal time and possible psychiatric evaluations. Furthermore, S.E.X-020-A-1 has shown great cooperation and understanding towards the S.E.X organization and it's goals and has been provided level 3 privileges, dependant on continued good behavior. This does not extend to any of the instances of S.E.X-020-B. Instances of S.E.X-020-C that have shown no significant anomalous behavior prior to their 18th birthday may be allowed to leave the site, but an effort should be made to recruit them into S.E.X itself. Those that do not become organization employees must be continually monitored for any anomalous properties. Instances of S.E.X-020-C may return and visit "Evergreen Haven" freely.

## **Description:**

S.E.X-020 is a 35cm tall statue depicting an imposing male cradling a voluptuous woman in its arms. A carving written in an ancient native brazilian dialect at the base of the statue reads "Let them be jailed by their desire for dominance, let their wasted strength go to their worthy jailor and may their jailor care for them in exchange for their boon." The statue is constructed from an unknown material, and does not show any signs of aging or wear. In addition, S.E.X-020 has been known to have glowing patterns appear on its surface during "laudable" and "dodeca" events. Estimates of S.E.X-020's age exceed 500 years at this time. What few records of the statue that the organization have uncovered all refer to it as the "Idol of the Laudable Man."

The anomalous properties of S.E.X-020 only activate when within 10 meters of a *Type A* male and at least three *Type B* males. Type A male adults are emotionally stable, physically fit and sexual generous, while Type B males possess notable "alpha male" tendencies (*and/or strong "cuckold" or "NTR" fetishes. See Test # S.E.X-020-1.2-A*). While ages for both types seem to vary, the minimum age seems to be what the society of the subject deems to be of legal adult age, while the max restriction in age corresponds with the upper limit of nominal childbirth.

When the Type A and B requirements are met a "laudable" event will happen. All Type B males present will undergo a full sexual shift from male form to female form of the same age they were or younger, while the Type A male undergoes a stage 3 A.D. "attribute drain" transformation. The type A males experience an increase in "masculine" traits, as if these traits are actively being drained from the Type B males. These traits include muscle mass, increased "handsomeness," increase penis and testicle size, increased virility, and increased height. These changes are proportionate to the number of Type B males affected, and in some cases unique and desirable masculine traits from a Type B will directly be transferred to the Type A (recorded examples include long hair, strong chins and sexual technique expertise). No means have been found to reverse these changes, and all subjects involved will see these changes as positive and "natural." The Type A male is afterwards designated as an instance of S.E.X-020-A, while the Type Bs become instances of S.E.X-020-B.

S.E.X-020-B will see S.E.X-020-A as their life mate and companion and seek to have intercourse and bear children sired by S.E.X-020-A. It is common for S.E.X-020-A to not undergo such a comparatively smooth transition, and to be alarmed by the sudden physical changes and sudden attention from instances of S.E.X-020-B, but instances of S.E.X-020-A will be drawn to protect and please instances of S.E.X-020-B nonetheless.

Furthermore, instances of S.E.X-020-B show further anomalus habits and abilities that seem to be designed to further increase the number of S.E.X-020-B instances under the care of their paired S.E.X-020-A, to the maximum of twelve instances of S.E.X-020-B. They will seek out Type B males and seduce them. During any intercourse an instance of S.E.X-020-B has with a Type B male, the Type B male will undergo the same transformation that happened during the "Laudable" event. They will become an instance of S.E.X-020-B and S.E.X-020-A will undergo another stage 3 A.D. transformation as described in the previous "Laudable" event. Further "laudable" events after the initial creation of the first three or more S.E.X-020-B instances have a greatly reduced effect on S.E.X-020-A. This diminishing returns effect is not fully understood, but speculated to relate to a maximum 'attraction' index for S.E.X-020-A instances. Once the twelfth instance of S.E.X-020-B is created with a connection to a specific S.E.X-020-A, all instances of S.E.X-020-B connected to that specific S.E.X-020-A will lose the ability and desire to create further instances of S.E.X-020-B. The Maximum number of S.E.X-020-B per instance of S.E.X-020-A.

Women who have sexual intercourse with instances S.E.X-020-A do not become instances of S.E.X-020-B, unless the women in question are in a long term relationship with a Type B male who is turned into a instance of S.E.X-020-B as well.

The children born from pregnancies between S.E.X-020-A and S.E.X-020-B instances are referred to as instances of S.E.X-020-C. S.E.X-020-B will initially only give birth to female offspring. Not until after an instance of S.E.X-020-A as acquired twelve instances of S.E.X-020-B will male children start to be born, with all twelve instances of S.E.X-020-B giving birth to male children conceived during "dodeca" events. All children sired by instances of S.E.X-020-C seem to have slightly to extremely higher intelligence, discipline, and inherent morality. Whether this is due to some anomalous effect or due to the high quality of parenting provided by instances of S.E.X-020-A and S.E.X-020-B is unknown. (see Addition S.E.X-020-3)

#### Discovery:

S.E.X-020 was initially discovered at a fraternity house on the campus of [redacted] state college on September 13th, 1989. A young man named Bobby Knight was kidnapped from his student aid office in the archeology department of the school by two fraternity initiates, who were undergoing their initiation challenge. The challenge was to "get a beta male" and bring him back to the fraternity house. It seems the last part of the hazing ritual required the initiates to beat the captive to near death. Luckily for Bobby Knight, he was still holding onto S.E.X-020 when he was put into the duffle bag and it's anomalous properties seemed to activate before the final part of the hazing ritual could begin. The two initiates and three senior members of the fraternity where all turned into instances of S.E.X-020-B and Mr. Knight became an instance of

S.E.X-020-A. It was after news reports of "Fraternities pushing for the ban of Milf-Shake on campus after freak accident!" began to circulate that the organization started to investigate, and uncovered S.E.X-020 along with S.E.X-020-A and five instances of S.E.X-020-B.

#### Addtion S.E.X-020-1.01:

After further research and interviews with instances of S.E.X-020-B, it is theorized that the female form they take is that of what their previous male form thought of as the "ideal woman" or closest possibility. Approval for further testing has been requested.

#### **Addition S.E.X-020-1.2:**

After the 7ths instance of S.E.X-020-B was created using agent Carlson [redacted] as the type B male, stronger screening must be used for all personnel at the holding facility. It was discovered that while not a believer in "alpha male mentality" himself, agent Carlson [redacted] had an extreme "NTR" fetish and actively sought out married women for sexual encounters.

Around this time, it was also noticed that S.E.X-020-A begane to encourage instances of S.E.X-020-B to go out and create more instances of S.E.X-020-B In addition, S.E.X-020 seemed to have been moved out of it's secure containment safe through unknown means. An investigation was held shortly after these events. See Interview log S.E.X-020-045

#### Addition S.E.X-020-2:

After Test # S.E.X-020-1.2-C, instances of S.E.X-020-B stopped seeking out type B males to convert and seem to have lost their ability to create further instances of S.E.X-020-B. S.E.X-020-A was able to ejaculate normally after the test and experienced no further transformations. S.E.X-020 does not seem to react at all to the current instance of S.E.X-020-A or any instances of S.E.X-020-B. When asked to hold S.E.X-020, S.E.X-020-B-12 replied "Um...why? We...we don't need it anymore."

#### Addition S.E.X-020-3:

After in depth research into S.E.X-020, Dr. Prince has proposed the "Evergreen Haven" initiative. See proposal S.E.X-020-1 "Evergreen Haven" initiative. <del>Undergoing Administration and morality committee review</del>. Administration and morality committee approval granted.

#### **Addition S.E.X-020-3.1:**

S.E.X classification changed to Brigid and protection/observation protocols updated. All new instances of S.E.X-020-A will be drawn from loyal organization employees and will be instructed to guide instances of S.E.X-020-C into employment at the Organization. "Evergreen Acres" has been renamed to "Evergreen Haven" and is to undergo upgrades into a full residential and research facility.

#### **Addition S.E.X-020-3.2:**

First generation of instances of S.E.X-020-C reach adulthood and have a 82% recruitment rate to direct S.E.X Organization employment while the other 12% opt in to be Organization agents planted into industries of their choosing.

### **Addition S.E.X-020-3.3:**

Second generation of instances of S.E.X-020-C reach adulthood. All instances are fathered by loyal S.E.X Organization employees. There is a 97% recruitment rate of direct S.E.X Organization employment, with the few choosing non-direct employment opting to be agents placed in other industries of their choosing. 100% rate of loyalty to the S.E.X Organization in the second generation of S.E.X-020-C. Research into possible "hereditary" loyalty and the insertion of such loyalty into unborn children approved. Denied, approval overridden by 11 to 0 Morality committee vote. Dr. Knight abstained from vote due to conflict of interest

# Note from Dr. Knight

"Lets get some things out of the way.

Yes, I am an instance of S.E.X-020-C.

Yes, I wouldn't be here if it wasn't for the "Evergreen Haven" proposal.

Yes, I abstained my vote due to my conflict of interest. But I fully agree with the committee's decision and only abstained in order to not complicate the matter.

Yes, even if you don't agree with me or the committee, I am still up for the dinner dates many of you have set up with me.

But we need to get one thing straight, the committee will not let the success of the "Evergreen Haven" proposal be an excuse to further push the already grey morality of what we are doing here into the black. We can spin instances of S.E.X-020-B as an extreme form of "rehabilitation" and gain the benefits of it with an excuse of "why not, they want to work for us!" But finding a way to make unborn children loyal to a group or individual is another creature entirely."
