- **Cheyenne Mountain Roofing Proposal:**
Tabled; the Board will seek additional bids.
- **Town of Sugar City – Water Leak:**
Gary Massey and Eric Roberts informed the Board about a major water leak at Nebraska and Highway 96. Access to underground valves will require **CDOT approval** to close the road. Sugar City does not have the resources to perform the repair.
 - **Commissioners agreed** to consider funding the repairs, pending quotes.
- **Sugar City Volunteer Fire Department Request:**
 - Requested assistance with purchase of a pump and water tank (\$3,000 total cost).
 - Department can cover \$1,500.
 - **Commissioners approved a \$1,500 contribution.**
- **Old Ambulance Review by Ellicott Fire Department:**
 - The department reviewed the unit and found minor issues.

- They will consider making a purchase offer.
