

# **Spring 2025 Class Session Policies**

### REGISTRATION

### MEMBERSHIP FEE

• There is a one time, \$40 per family session membership fee. One fee per family. The non-refundable \$40 membership fee is due upon enrollment. The membership fee is waived for Dance With Me and Baby Dance With Me mini-sessions. The non-refundable last monthly tuition installment is due upon enrollment in order to finalize your enrollment and reserve your classes.

### **TUITION FEES & PAYMENT**

- Tuition rates are for the full session (January- June including studio holidays) from January 27th through June 16th, not by the number of classes in the month. The full session of dance includes a minimum of 18 lessons. Tuition fees can be paid in full or monthly. Clients who opt into a monthly payment plan will have the credit/debit card on file charged for the monthly balance due on the 5th of each month February- May.
- Clients who opt to pay the session fee in full will have their credit/debit card on file charged for the full session fee upon enrollment.
- All clients are required to submit a credit/debit card at enrollment. After enrolling (paying the last monthly payment or full session fee and membership fee), tuition will be charged to your debit/credit card on the 5th day of each remaining month beginning February 5th, 2025.
- Clients can check their balance at any time by logging into their account at LittleLeapsKids.com
- Clients/ Cardholders authorize Little Leaps to charge their provided credit/debit card for tuition and membership fees.
- Tuition and membership fees are non-refundable.
- A \$35 service fee will be charged for all returned checks.
- Accounts not paid within terms are subject to an accruing 5% monthly finance charge until paid. Little Leaps reserves the right to discontinue service to any customer with an account more than 60 days past due.

- One Weekly 45 min class- \$425 Full Session fee or 5 Installments of \$85
- One Weekly- 60 min class- \$525 Full Session fee or 5 Installments of \$105

### WITHDRAWAL

- There is a one month minimum for all lessons. A one-month notice from the fifth of the month is required to discontinue any payments for the following month.
- To withdraw a parent must inform Little Leaps in writing by logging into your account at
  LittleLeapsKids.com and selecting "drop a class" or email <a href="Office@LittleLeapsKids.com">Office@LittleLeapsKids.com</a>. Charges will
  continue to accrue to your account until Little Leaps has been notified of your withdrawal in writing.
  Automatic debit/credit card charges will stop after the 1 month notice period. Refunds or credits will not
  be given for tuition.
- Payments made for membership and tuition are non-refundable.
- There are no refunds of tuition for classes you're scheduled to attend whether or not you attend the class, and there are no refunds for membership fees or the last monthly tuition installment payable upon enrollment
