The Junction City Water and Sewer utility appreciates your timely payment of these quarterly utility bills. Utility payments may be mailed to PO Box 93, Junction City, WI (as stated on the water bill) or on PayClix online (as stated on the bill) or in the utility drop box at the rear of the former US Bank building at 972 Main Street or given to a Village employee.



Thus going forward with this utility bill, all bills not paid in full by November 20, 2024 will be disconnected from service on November 25, 2024 without exception and without further notice including a \$25.00 to \$50.00 re-connection fee. (This constitutes your formal written notice for disconnection on November 25, 2024).

The 2024 garbage and recycling scheduled pick-up day is **Friday.** (Holiday week to Saturday). Contact Waste Management Customer Service 1-888-960-0008 or 1-715-421-3939 and the Village at 715-457-2353 (we track their service). Please place garbage in bags into the garbage cans if you use them. (per Village ordinance) If a cover is off or the can tips over loose garbage gets strewn onto the street and/or into your neighbor's yard. Please, please, please to not flush wipes (even though they may say "flushable") down the toilet. Place in trash instead. These wipes cause problems at the wastewater treatment plant plugging the pumps creating extra expense to you the utility customer. The Village has accepted a proposal for a five year contract with Harter's Disposal for garbage and recycling services to start in 2025

when our current contract expires at the end of this year. Future pick-ups will be in dumpsters provided by the collection service to provide for mechanical rather than manual pickup. Both garbage and recycling pick-up will be weekly with dumpsters provided by Harter's in December. Pick-up day is yet to be determined. More information to follow. The new quarterly rate will be \$60.00.


Snow shoveling on Main Street sidewalks will be optional, not mandatory, this winter. The County will plow Main Street curb to curb.
