1. Introduction

The Khyber Pakhtunkhwa Judicial Academy (KPJA) has a statutory mandate to build capacity of all justice sector stakeholders, to hold conferences, seminars, lectures, workshops, symposia, and to establish liaison with research institutions, universities and other bodies including the Federal Judicial Academy, to further the cause of administration of justice.

With this end in view, the Academy arranged 06 – day training on capacity building of the Excise & Taxation Staff in narcotics control.

2. Purpose of the report

This report aims to highlight general layout of the training and assess the quality and impact of training conducted by the Academy from 18th-23rd July.

3. BACKGROUND

Excise & Taxation Department was an attached Department of the Board of Revenue of the Provincial Government till 1997. From 1997 to 2000 it remained attached with the Finance Department and was upgraded as an independent Department in November 2000. The main function of the department was to collect different provincial taxes, duties, fees, and cesses. In 2019 the Khyber Pakhtunkhwa Control of Narcotic Substances Act, 2019 (Khyber Pakhtunkhwa Act No. XXXI of 2019) was enacted and power under the said law was conferred upon the Excise and Taxation department and Control of Narcotics Wing established to deal with the narcotics cases. Its duties now extend beyond tax facilitation to track down the use of unauthorized and vehicles with tempered chassis numbers and the trafficking of prohibited narcotics.

Due to change in job description and responsibilities, the Director General, Excise, Taxation & Narcotics Control, Khyber Pakhtunkhwa vide letter bearing No. 567/NCW/Training, dated 20/12/2021, requested the Khyber Pakhtunkhwa Judicial Academy for capacity building of staff of Excise, Taxation & Narcotics Control department in order to improve their knowledge and skills in the newly assigned area of narcotics control. The proposed training also envision to improve upon in the area of field job i.e. investigation and court proceeding as it was adversely affecting performance of officers/officials of the department.

Following a series of discussions between representatives from Excise, Taxation & Narcotics Control department, and the Faculty of KPJA, training modules, participant selection, activity schedule, and selection/nomination of resource persons were chalked out. It was also decided that the proposed training would be undertaken in two batches of about 25 trainees each. List of participants of the Batch-I is "Annex A".

4. LEARNING OBJECTIVES & OUT COMEs

Key learning objectives of the training were to:

- imbibe professional ethics and code of conduct
- sensitize participants on the Khyber Pakhtunkhwa Control of Narcotic Substances Act,
 2019;
- enhance knowledge and develop practical skills relating to search & effective investigation techniques for collection and handling evidence; and
- gain an understanding of the investigative procedures and best practices specific to narcotics control.

At conclusion of activity, it is expected that the learning outcomes have been successfully achieved. Post training evaluation (impact, quality of and feedback on training given below) endorses accomplishment of the objectives and successful achievement of the learning outcomes.

4. Proceedings

Registration and Pre-Evaluation: Registration of the participants and their pre training evaluation were conducted.

Inaugural Ceremony: The training formally commenced with an inaugural ceremony chaired by Ms. Farah Jamshed, Director General, Khyber Pakhtunkhwa Judicial Academy. Mr. Zafar ul Islam, Director General Excise, Taxation and Narcotics Control Department was the Chief Guest of the ceremony. The Dean Faculty and all Directors of the Academy were in attendance. The Director-General Khyber Pakhtunkhwa Judicial Academy welcomed the participants and reflected upon the aims and objectives of the training course. The Chief Guest, Mr. Zafar ul Islam emphasized the significance of capacity building in the field of narcotics control. He highlighted the evolving responsibilities of the Excise, Taxation, and Narcotics Control department and stressed the importance of acquiring necessary knowledge and skills to effectively combat narcotics offenses.

VISIT OF THE FORENSIC SCIENCE LABORATORY, PESHAWAR

To complement the theoretical knowledge and practical skills provided during the training sessions, the Academy arranged visit to the Forensic Science Laboratory, Peshawar (FSL). The visit to the FSL allowed participants to observe and learn from experts in the field, ensuring a deeper understanding of the forensic processes and techniques employed in the investigation and prosecution of narcotics cases. They also visited different departments of the facility and were apprised with practical demonstrations like chemical analysis of contrabands and documentation procedures.


Post-Evaluation: At the end of the training, the post-training evaluation and assessment were conducted.

Represents 25% level of proficiency- indicated by 42% of the trainees.


Represents 50% level of proficiency- indicated by 42% of the trainees.


